



Loss \$25,000, \$18,500 Insurance--Will Probably be Re-Built.

At 7:00 o'clock last Monday morning, a very small fire was discovered near the engines in the E. T. M. & I. Co.'s mill, better known as the Bearinger mill. The hose were taken out to attach to the mill hydrant,

The alarm was carried to Emery's mill (one block to the east,), but reached the water works nearly as quickly, when it was soon known that there was a fire in town by the shrill blasts of the fire whistle. A number rushed to the hall for the hose carts, which were run out and in a very short time on the scene, but it was found that it would be impossible to save the mill, so the fire department set themselves to work to prevent the fire from spreading.




