CLEAN POLITICS.

The Monitor's Slanderous way of Conducting a Campaign.

We take the following from the Tawas Bay Advocate.

We have not as yet taken any sides in the political issues of the day, neither will we in the future, or at least in the campaign of 1892. A paper makes more enemies than they gain dollars, no matter what side of the question it takes. We do not believe in puffing a man up, and writing columns of editorials in telling how he is working, and all we get in return for it is a promise that he will help you out in some future time, neither do we believe in slandering a man because we have some personal spite against him. The time to work out a personal spite is not when we are trying to select a man for the whole people, who is to take care of our laws for the next two or four years.

But there is one thing that we do believe in, and that is that if the people nominate a man for office, without his seeking it, we should afterwards help elect him, or if we don't like a man, or his business, keep still. Surely if the whole people, with their brains and experience, think that a man is fitted for an office, they should have their way, and not follow the foolish ideas of one certain disreputable man.

Featherly, our esteemed contemporary, or rather our slanderous contemporary, in several articles in the Monitor, for the last two or three weeks has, in his way, been saying a good deal in regards to some of our nominees from this end of the county, of course we don't mean, because he is saying a good deal he is doing any good, or any harm to anyone, as he has never slandered a man but what he has elected him. In several different articles he has been trying to paint Mr. Murphy, candidate for sheriff on the democratic ticket, as black a villain as ever lived. We have nothing to say in regards to his articles about Murphy, more than that we don't think it is right to run him down, or any other man, just because he lives in a rival town. The Monitor stated that two years ago Mr. Murphy circulated the report that he had sold his business for the purpose of gaining votes, that is untrue, as no such report was either talked of or published. Mr. Murphy was at that time nominated for sheriff by acclamation, and made a good run, considering that he was running against a man who was up for his second term. This year Mr. Murphy was not even a delegate to the convention, and did not seek the nomination, the nomination sought him, as did the office of Supervisor.

Mr. Murphy has been a resident of Iosco county for 28 years, and has always been known to pay his debts and do business on square principals. He is not a rascal, or is he the keeper of a dive, or a frequenter of one. He is not an old whisky soaked bum as the Monitor would paint him. If a person wants to see which is the man to be slandered he can tell by looking at the record of both men. Mr. Murphy has never been requested to move out of town by the council, but has been elected to the following offices by the citizens of our city and county. He was dep'y. Sheriff for two years under Esmond, and four years under Lanktree, and it has been said by attorney's Judge Tuttle and Judge Simpson that Mr. Murphy was one of the best officers they had in their judicial circuit. He has been counselman for the last five years, game warden of this county, dep'y. county clerk, Real estate dealer and Notary Public. We have also heard it said, since we have been in the city, that Mr. Murphy has had nothing to do with the liquor traffic for the past two years and a half, since he has been engaged in the newspaper and other business.

Mr. Murphy was nominated by the electors of his party of their own free will, unsought for by himself, as he thought that there was too many others in the race for him to enter it.

The Monitor says, "Mr. Cox is our next sheriff," but if the people take as much stock in his saying as they have in the past, Mr. Murphy is our next sheriff.



SMART as Mr. Blaine undoubtedly is, he can easily be caught by the "taffy" of smaller men.

EVEN rich Mr. Blaine gets a price for writing Republican campaign documents. Come to think, any man who does it ought to be well paid for it.

THE vitriolic Ingalls finds working for newspaper syndicates more congenial and more profitable than working for the Republican National ticket this year.

THOSE Tammany war clubs and tomahawks, are being quite vigorously used on Republican heads these days, contrary to Republican and mugwump prophecies.

IT is a noteworthy fact that the most popular men with the republican masses, such men as Blaine, Foraker and Reed, were all opposed to the re-nomination of Mr. Harrison.

THANK heaven, the democratic managers have put no woman on the stump; women were made for something higher and nobler than stump-speaking and political wire pulling and, while good and pure women may engage in it, we rejoice that they are not relatives of ours.

THE Republicans have forgotten something. Nobody has yet said a word about "British gold" being used in this campaign. The Republican managers are to busy manipulating the money furnished by the Barons of "protection," to throttle the voice of the people, perhaps.

IT is now well nigh certain that after the 4th of next March, the Republicans will control the U. S. Senate. This is encouraging to tariff reformers. Remember, Democrats, we have only to retain control of the House and elect Mr. Cleveland to be in a position to give the people relief from the tariff burdens they are now compelled to carry.

THERE is an interdependence between the McKinleyized Republican party and the trusts. The trusts supply the funds by which the Republican party is to be returned to

power, and the party hopes to pass the force bill, surround the ballot boxes in the southern states with bayonets and maintain itself perpetually in power. In the language of the New York Tribune, there are 100 tariff measures in the force bill. The party is in the bondage of trusts and is willing to subvert the liberties of the people to permit their masters to amass wealth at the expense of the toiling millions.—Utica (N. Y.) Observer.

A Qualified Man.

Charles R. Henry, candidate for the office of Probate Judge is a person whose long years of active legal practice, and his extensive acquaintance in the County, has particularly fitted him for the position. If elected he pledges himself that he will personally attend to the duties of that office at Tawas City, each and every week, on the day prescribed by the statute.—Tawas Bay Advocate.

Penalty for Bribery.

We take the following from the Public Acts of the State of Michigan, for 1891:

Sec. 43 It shall not be lawful for any elective office, with intent to promote his election, or for any other person, with the intent to promote the election of any such candidate, either:

FIRST, To provide or furnish entertainment at his expense to any meeting of electors, previous to, or during the election at which he (shall) be a candidate; or,

SECOND, To pay for, procure, or engage to pay for any such entertainment; or,

THIRD, To furnish any money or other property to any person, for the purpose of being expended in procuring the attendance of voters at the polls; or,

FOURTH, To engage to pay any money, or deliver any property, or otherwise compensate any person for procuring the attendance of voters at the polls; or,

FIFTH, To contribute money for any other purpose intended to promote an election of any particular person or ticket, except for the purpose of defraying the expenses of printing, and the circulation of hand bills and other papers previous to any such election, or for conveying sick, or infirm electors to the polls.

Sec. 45. Any person who shall knowingly violate any of the provisions of this act, or shall willfully neglect or refuse to perform any duty enjoined upon him hereby, or shall disclose to any other person the name of any candidate voted for by an elector, the contents of whose ballot shall have been seen by such person, or shall in any manner obstruct or attempt to obstruct any elector in his exercise of his duties as such elector under this act, shall be deemed guilty of a felony, and on conviction thereof shall be punished by a fine of not exceeding one thousand dollars, or imprisonment in the State Prison not exceeding two years, or by both such fine and imprisonment in the discretion of the court.

PROCLAMATION.

I, Michael Murphy, Supervisor of the Township of Tawas, County of Iosco and State of Michigan, as required by law, do hereby warn the inhabitants of said Township, of the provisions an act entitled, "An Act to Maintain Political Impunity" being sections 9377 to 9386 inclusive, of Howell's Annotated Statutes, which said act defines the offences of bribery and corrupt practice at any public election, in this State, and makes it unlawful to sell, barter or give away any liquors on the day of any such elections, and prescribes the penalties for violations thereof.

All violations of said act will subject the offender to prompt and speedy punishment. Sheriffs, Marshals, Constables and all police officers are required to close all houses or places found violating the provisions of the said act and to report forthwith all such violations to the Prosecuting Attorney of said County and to the undersigned.

OFFICIAL BALLOT.

The method of voting under the new election law of this state is not difficult, when once the principle is understood. No elector needs to lose his vote, if he will but exercise a little care. All the tickets regularly put in nomination will be printed side by side on one sheet of paper as below. This will be the official ballot, and is the only one allowed to be voted. The voter will be given one of these official ballots by the inspector of election. The voter should see that the inspector's initials are put on the back of the ticket in one corner. The voter must take this official ballot with him into the booth alone. At the head of the Democratic ticket he will find first a vignette or design, under that the word DEMOCRATIC, and under the latter a small open space. Let the voter make a cross in the little square and that is all that is necessary. That makes the official ballot straight Democratic vote, counting one for each candidate on the Democratic ticket.

Bear these two Rules in Mind—to vote a straight Democratic ticket put a cross in the square at the head of the ticket and nothing else. To split a Republican ticket, put a cross in the square at the head, mark out the name of the Republican candidate and then put a cross in the square before the Democratic candidate. (There should be a square before the name of each candidate, but as we haven't enough for that purpose, we just use them on the county tickets.)

We have been unable to obtain the vignettes of all the tickets, so we have omitted all. The design chosen by the Democrats is the American flag with the arm of labor, and that of the Republicans the flag with the portrait of Harrison in the centre. Voters, remember the Democratic emblem, and that our ticket is on the extreme right or last column. Any person making a cross at head of ticket votes a straight, if voter wishes to vote for candidate on opposite ticket, mark out rejected candidate and make a cross in the square before the name of desired candidate for same office.

Our Prosecuting Attorney.

In looking over the calendar for the present term of the Circuit Court we find the case of the H. M. Loud & Sons Lumber Co. against the city of Au Sable which was brought to recover the taxes paid by that corporation for the year 1891, amounting to over \$9,000. A peculiar feature about this suit is that our present Prosecuting Attorney, M. J. Connine, is the attorney for the Lumber Co. in the suit. As we understand the matter, it is the duty of the Prosecuting Attorney to endeavor to protect the towns and county in the levy and collection of taxes, instead of attempting to defeat such collection.

Mr. Connine was Prosecuting Attorney when these taxes were assessed and therefore was the legal adviser of the Supervisors in the levy and assessment of taxes, and we cannot see how he can now consistently claim that these taxes were not properly and legally assessed, when such assessment must have been made under his direct and special supervision.

We are anxious to know what the taxpayers of Au Sable, and the county, generally, think of this action on the part of Mr. Connine.

We understand there is also a similar matter pending in the Wayne circuit court in relation to certain taxes which the township of Oscoda is endeavoring to collect, which taxes were assessed and levied under the direct supervision of Mr. Connine. He is attorney for the parties interested in avoiding the payment of the same.

We do not question the legality or illegality of these taxes, but the fact that Mr. Connine is taking these inconsistent positions, and is thrusting upon the townships and cities of the county the burden and vexation of law suits to collect their taxes, or to protect those already collected, when it is his duty to, and he is paid a salary for, properly advising and protecting the townships in the levy and collection of taxes,

is a matter of special interest to every taxpayer in the county, and should receive serious consideration before you cast your ballot for Prosecuting Attorney next week Tuesday.
