A Standish dispatch to the Bay City Tribune says the Maple Grove school, five miles northeast of that city, has been closed owing to an outbreak of small pox. It reports three cases in two families.

Work on the new Sherman county road has been suspended until spring. The stone has been put on a little over one mile of this road and it is a credit to contractor Bert Fowler and the county road commissioners.

Dr. Crane put most of the ordinary "deer slayers" of this locality to the bad. He went out to camp Saturday and came back Monday morning with a fine buck. Doc says shooting deer is easy when you know how.

Lee E. Joslyn, of Bay City, has been named as referee of bankruptcy for the southern district of Michigan, and will soon remove to Detroit. George A. Marston, of Bay City, succeeds Mr. Joslyn as referee for the northern district.

Of 3,132 deaths in the state during October, according to the mortality statement issued by the secretary state, 22 were caused by small pox. There were 210 deaths by violence during the month. The number of births reported for the month was 4,662.

Thirty-three warrants were issued in one day last week for violators of the local option law in Presque Isle county. That would look as though they intended to enforce the law in that county at last. The success or failure of local option depends entirely on the enforcement of the law.

Mrs. H. N. Gamble, of Mount Morris, N. Y., came last Friday, to spend the winter with Rev. and Mrs. McCarroll. Mrs. Gamble is an active church and W. C. T. U. worker, and has spent a couple of years among the mountaineers of the south and the "crackers" and negroes of Florida.

The state game warden department has been doing a land-office business of late, confiscating hides caught before the season began. Over five hundred dollars worth of pelts were taken at Alpena and the owners were soaked a heavy fine, and about that many more confiscated at Manistee, where the owners were again losers.

A. F. McDonald, of AuSable, died unexpectedly last Monday from heart disease. The deceased was one of the pioneer settlers of that city, and was well-known and highly respected throughout the county. He has for years been a member of the board of supervisors, representing the first ward of that city. The funeral was held yesterday.

Word has been received here from Cleveland that Miss Margaret McRae, formerly a teacher in the Bay City public schools, is ill in a hospital in that city. She recently underwent an operation there. Miss McRae has taught school in Cleveland for several years.—Bay City Tribune. Word was received here last evening announcing Miss McRae's death Tuesday.

According to figures just given out, the state highway department has expended since July 1 the sum of \$131,719 as the state's portion of expense of construction of highways during that period. This sum represents award on 190 miles of good roads constructed according to the specifications of the law governing state awards. The work has been widely scattered, 60 of the 83 counties in the state having come in for a share of the state's money.

Rev. McCarroll, the new Presbyterian minister, was for five years a home missionary among the southern mountaineers in western North Carolina. Mrs. McCarroll has been among the southern mountaineers for eight years, having been for three years a teacher in the Presbyterian schools in Asheville. Mr. and Mrs. McCarroll labored two years in Tennessee, and came from there to here. Two of Mr. McCarroll's brothers are missionaries, and are home from the island of Cyprus and a sister-in-law labors in Syria.

A sad, and what may prove a fatal accident, occurred in this city Wednesday evening, when Julius, the 10-year-old son of Adolph Steinhurst, accidentally shot his eight-year-old brother, Alfred. The boys were cleaning up the wood shed when Julius picked up a shot gun which had been left by an older brother and in some manner it was discharged, the load of bird shot striking Alfred in the leg between the knee and the body, tearing a great hole in the flesh, and cutting an artery. Dr. Schmalller was called and dressed the wound, but it was thought best to take the lad to the hospital at Bay City. His father and Dr. Schmalller took him there yesterday morning. LATER: A message received last evening announces the death of the boy.

Arthur Kaiser died at his home in East Tawas, Friday night, November 18, after several months suffering from tuberculosis. Had he lived until today the young man would have been 28 years of age. Practically his entire life was spent in the Tawas where he was high-respected by a large circle of acquaintances. He is survived by a widow and little son, besides his mother, Mrs. Martha Budd, three sisters, Mrs. G. H. Hadwin and Miss Maude, of this city, and Miss Kittie, of Cleveland. The funeral was held Wednesday afternoon under the auspices of the I. O. F., of which he was a member, and the East Tawas Band, of which he was the leader for a number of years. The remains were laid at rest in the Tawas City cemetery.

### Notice!

At a meeting of the Common Council of Tawas City, held Friday evening, November 16, 1910, the following resolution was passed:

In view of the prevalence of small pox throughout the state and the deadly nature of the disease and the danger of its spreading, the Common Council earnestly recommends as follows:

First:—That all citizens and residents of Tawas City who have not been vaccinated within the last four years have the same done at once.

Second:—That all school children in the public schools who have not been vaccinated in the past four years, be vaccinated, the school board to see that the same be carried out promptly and that any child refusing to be so treated shall not be allowed to attend school until vaccinated.

Third:—That the city physician attend to the vaccination of school children, the city to pay for extra services of physician in attending to same.

Fourth:—That all business and public places be fumigated at once, including schools and churches, and any suspicious cases reported at once to city physicians or Board of Public Health.

Supervisors' Proceedings. Continued. Tawas City, Mich., Oct 10, 1910. To the Hon Board of Supervisors. Gentlemen:—The board of county road commissioners of Iosco county respectfully submit the following as their annual report: On April 8, 1910, Board met and adopted as a county road "that piece of road from northwest corner of section 11, T. 21 N., R. 6 E., running southerly to quarter point between sections 11 and 15, township of Sherman, to be called the Grant-Sherman county road," and ordered a survey and profile to be made of same. A survey was also ordered of that part of the Alabaster road beginning at a point on the brow of the hill directly north of the big gully and about 40 rods south of the section line on south side of section 11, running thence northerly to the section line on west side of section 11, the center line of said road conforming as near as may be to the present travelled road.

On June 16, Board met and adopted as a county road to the Alabaster county road, 7.14 miles of highway commencing at a point on the section line between sections 2 and 11, T. 21 N., R. 7 E., distant from the center line on said road 625 feet, and running southerly westerly the said 7.14 feet. It was also voted to advertise for bids for building one mile of said road. Bids were also asked for building second mile of said clay road on the Van Etan Lake county road, and for grading, brushing and stumping one and one-half miles of the Grant-Sherman county road.

On July 11, the Board met and accepted bid of Birt Fowler for grading, brushing and stumping out and ditching one and one-half miles of the Grant-Sherman county road, at his bid of \$940. Also voted to advertise for bids for stoning same.

Board also accepted bid of Birt Fowler for building one mile of Alabaster county road as follows: grading, stumping and grading, \$500.00; claying and sanding, \$565.00; building four culverts, \$100.00; total, \$1,165.00. August 1, 1910, Board met and accepted first mile of said clay Van Etan Lake county road, and accepted bid of Duncan McMillan and George F Stevens for building second mile of same at their bid of \$1,000.00. 
