And that means much, for it means a deepening and strengthening of home ties and those of locality, all of which is greatly needed in our American

The lack of educational advantages in the country, particularly in the ed in city high schools, has heretofore have preferred to live on the farm. That farmer boys and girls have ambitions educationally is demonstated by a visit to any high school. Even our own we find one of the pupils so eager to gain an education that he walks to and from his home in the country, three and one half miles away, morning

There is now a movement under way to let what is called the consolidated school take the place of the one or two room buildings scattered over a school district. This seems to be the only solution of the problem. The distance from the central school is covered in wagons or automobiles which call for children and the cost of the service i more than compensated by the advan-

> The school has three floors: the basement, the first floor and the attic. The main story contains the school room, so arranged that the children face the east. There is abundant light from the north and west and ground glass windows at the rear admit the sunlight necessary for sanitation. The school room has adjustable seats and desks, a stereopticon screen, a smal organ, book shelves, proper sanitation, toilet rooms with hot and cold water.

The attic contains the manuel training benches, where eight or ten children may work at one time, a gas range and all the other apparatus for the experimental cooking.

Money in Beans.

When Michigan's bean crop of 1910 shall have been converted into the baked and other articles of food almost \$20,000,000 will have been spent for the product by the people of the world. Reports show that Michigan grew 6,-150,000 bushels last year, easily retail price of beans everywhere, excepting the selected, hand picked variety, is 10 cents a quart.

While the crop was larger than in 1909 in some sections it was badly damaged by rains, so that the amount of merchantable beans is no greater than a year ago, hence the wholesale price is not apt to show much of a change, according to members of the Michigan Bean Jobbers' association at the mid-winter meeting.

Iosco county farmers have yet to get their share of this great wealth that is going to the agriculturists of other sections of the state. Our farmers have not gone very heavily into bean raising, however, a few have tried them with gratifying results. We have never seen better beans raised in the banner bean ection of southern Michigan than were raised in Iosco last fall. Beans have filled the banks with farmers' money where they have been raised, and ou tarmers have but to resort to this ad ditional means to fatten their farm dividends. We can raise 'em here a good as any place.

Legislative News from Lansing

Monday the senate quickly tabled the concurent resolution from the house asking for a special committee to arrange a junket program.

Former state highway commissioner H. L. Earle is spending much time here in the interest of a good road bill. Few men have better ideas of practical plan for road building than Earle. Just what will be accomplished at this session is impossible to say at present.

It is claimed that when the women suffragrets lost their fight in the house their last chance at this session went glimmering, as a poll of the senate shows 16 senators opposed to the proposition with five non-committed, three of whom are undoubtedly opposed. There is but little doubt that the liquor interests had much to do with the defeat o this matter.

Senator Taylor, of Kalamazoo, Tuesday introduced a bill repealing the mort gage tax law and providing for a specific tax of one per cent, upon recording and at the expiration of each successive four years. It will differ in this point from Senator Fowle's bill also which provides for a single tax of fifty cents on each \$100 on the face of the mortgage upon recording. Senator Taylor's bill is unique in that it provides for the appointment of the moneys collected by the mortgage tax by the county treasurer. Twenty-three per cent will go to the state; 27 per cent to the county and 50 per cent to the locality in which the mortgaged property is located. This appointment is based on an estimate of the present division of mortgage tax moneys. Senator Fowle's bill provides that the money so collected shall be paid to the general fund of the state. 

In the first place, the production of hog cholera serum is complicated by many difficulties. There are so many the laboratory workers engaged in its factors involved, and each so hard to control. The difficulty in getting suit able pigs for the work, and their inordinately high price, the expense of thoroughly testing all the serum before sending it out, and the frequent lack of potency of serum even when all the requirements of the process seem to have been fulfilled-these influences and others militate against Farmers engaged in swine production of serum that will answer the requirements of availability, efficiency, safety, ease of application and, above all, cheapness.

Efforts made to produce a satisfactory serum or vaccine based upon radically different methods of serum application have met with discouraging results. It seems to be for the interests of the swine breeders that we continue our policy of developing and improving the hog cholera serum along the lines pursued since the inaurguration of the work. Our confidence in the efficiency of the serum has been shared by many of the most extensive swine breeders of several states.




