**Politics.**

The past week has seen many changes in the political line-up of all parties in Michigan. It was stated in our last issue that E. O. Wood, of Flint, would be democratic nominee for governor. Mr. Wood consented to make the run after all other prospective candidates had declined to stand. However a strong effort was brought to bear upon W. N. Ferris, of Big Rapids, and he was finally prevailed upon to make the run, and Mr. Wood promptly withdrew, so that the nominee will be Woodbridge N. Ferris, of Big Rapids.

James W. Helm, of Adrain, is out for the democratic nomination for lieutenant governor, and William F. McKnight, of Grand Rapids, for congressman-at-large.

Hubbard Head, Roscommon county, for state senator from the 28th district, and James Hull, of Oscoda, for representative, are two other candidates of the democratic party for whom petitions have been filed.

A. M. Fleischhauer, of Reed City, is a new candidate for state senator from the 28th district, on the republican ticket.

A new slant took place in the republican race for congress in the tenth district, Mayor Woodruff, of Bay City, withdrew as candidate for the republican nomination and announced himself as a candidate for the new progressive party for the same office. This leaves Congressman Loud and Frank Buell to fight it out for the republican nomination.

The new progressive party held their convention at Jackson last Saturday and decided to put a full ticket in the field in Michigan, to include state officers, congressional and legislative candidates and in all counties possible candidates for county offices.

**A New Birth of Freedom.**

The nomination of Woodrow Wilson for president means a new Democracy. It means a new epoch in American self-government.

The Democratic party at last has broken its shackles. It has emancipated itself. It has rehabilitated itself in power and principle. It has turned its face to the rising sun to re-establish the faith of the American people in their own institutions.

Woodrow Wilson will be the next president of the United States. But he will be more than that. He will be the first president of the United States in a generation to go into office owing favors to nobody except the American people and under obligations to nothing except the general welfare.

No political boss brought about his nomination. No political machine carried his candidacy to victory. No coterie of Wall-st. financiers provided the money to finance his campaign. He has no debt to pay to corrupt politics or to corrupt business. He was nominated by the irresistible force of public opinion, and by that alone. He stands before the country a free man.

The American people have set out to regain possession of their government, and Woodrow Wilson was nominated for president because he embodies that issue. The bosses and the plutocrats who tried to prevent his nomination were beaten by the power of the people, and the power that will elect him.

With Woodrow Wilson as the Democratic candidate for president it makes no difference what Mr. Roosevelt does. It makes no difference how many third parties he organizes. Progressive Democrats and progressive Republicans now have a candidate of their own. The contest between Mr. Roosevelt and Mr. Taft is now a contest for the control of the republican organization, and nothing more. The menace of a third term no longer hangs over the country. The menace of personal government no longer threatens American institutions. The United States is not to be Mexicanized. It is to be re-Americanized.

It is because Gov. Wilson represents this vital principle that The World so persistently urged his nomination. It is because Gov. Wilson represents this principle that the opposition wishing the party was forced to surrender. It is because Gov. Wilson represents this principle that he will be triumphantly elected in November. Such a man is imperatively needed, and the American people, true to their traditions in every crisis, have again found him.

Gov. Wilson's nomination means that the rule of the boss is over. It means

that the partnership between corrupt politics and corrupt business in national politics is forcibly dissolved. It means that the old regime of protection to privilege and plutocracy is on the scaffold. It means that the old gods are dead.

The United States is back to the benediction pronounced by Abraham Lincoln on the battlefield of Gettysburg—"that this Nation, under God, shall have a new birth of freedom, and that government of the people, by the people and for the people shall not perish from the earth."—New York World.

**To the Republicans of the Tenth Congressional District**

Having announced my candidacy for the nomination of congressman in this district on the Republican ticket, it naturally follows that I should present to the people my views relative to issues which at present are being most discussed. The bare statement that a man is a progressive or a conservative should carry little weight, for his ideas of progressiveness or conservatism may differ very much from the popular definition. His declaration of belief in the principles advocated by leading progressives is vague and indefinite unless fortified by his interpretation of those principles. Therefore, in order that the people may know where I stand in relation to such principles, I make the following announcement:

I favor a general revision of the tariff on a decending scale. I believe import duties should be imposed only to the extent of equalizing the difference in the cost of production at home and abroad. As this difference consists mainly in the cost of labor, the American wage-earner would derive the chief, if not sole benefit. Reasonable exceptions should be made in favor of new and experimental industries, but in such cases the imposition of excessive duties should cease when the period of infancy has passed.

Sugar may be cited as a product of such a class of industry. If there was ever reason for protective tariff on anything, it applies to sugar. Our production of beet sugar in 1904-5 was 216,178 tons. In 1910-11 it was 510,000 tons. We imported last year 1,719,400 tons of sugar, all of which could have been produced in this country. When we develop such an industry as iron or steel we do so at the expense of our natural resources, for every ton of iron manufactured means a ton less of supply, but when we produce a ton of sugar, instead of having reduced our source of supply we have placed ourselves in a position to produce more from the same source.

I advocate the primary election system for the nomination of all political candidates, including the President of the United States. Laws providing for such primaries should be plain explicit, free from ambiguity and devoid of subterfuge. If the people have the right to choose their own rulers, means should be provided for the exercise of such rights without danger of their choice being nullified by caucus manipulators or disregarded by convention bosses.

I am in accord with those who advocate the initiative and referendum as applied to legislative enactments. With the initiative and referendum in operation it will lie within the power of the people to provide for the recall of judges or decisions should they deem it desirable.

The federal government should, I believe, encourage, and, so far as the organic law will permit, aid in the building of good roads throughout the land. Not only does the extension of the free delivery service depend largely upon the condition of the public highways, but the cost of food products is regulated in a great measure by the facilities afforded for bringing them to market.

I believe in big business; therefore, I favor a federal incorporation law which shall permit the massing of capital, but with proper federal inspection and adequate federal control, so that small business enterprises cannot be crushed by unfair competition or consumers be overcharged by monopolization.

One of my competitors declares that he is "absolutely opposed to reciprocity with Canada or any other country." On the contrary I believe in reciprocity with all nations, but under terms favorable to our interests. It is generally known that all our trade with European and Oriental nations, also with Canada and the Central and South American Republics, is conducted under treaties involving reciprocity. I opposed to the proposed Canadian reciprocity treaty. It devised purely in the interests of the great manufacturing trusts and its effect would have been harmful to our agriculturalists.

Up to the present the tendency of immigrants has been to congest our cities rather than locate in farming communities. I believe our laws relating to immigration should be so amended as to favor the agricultural immigrant above any other class. Our native food supply is barely keeping pace with the natural increase of population. This condition would be much relieved if foreigners, upon reaching our shores, should become producers instead of consumers.

The natural resources of the nation should be developed and improved under the watchful supervision of the government, but not to the exclusion of private enterprise and private capital. 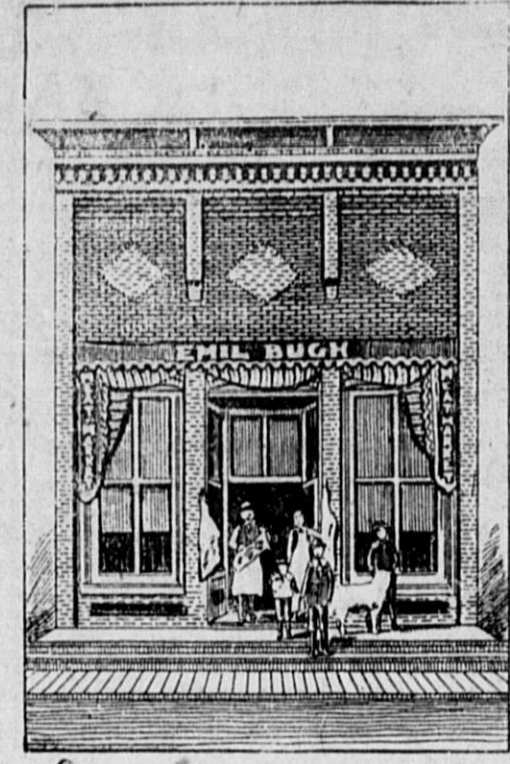

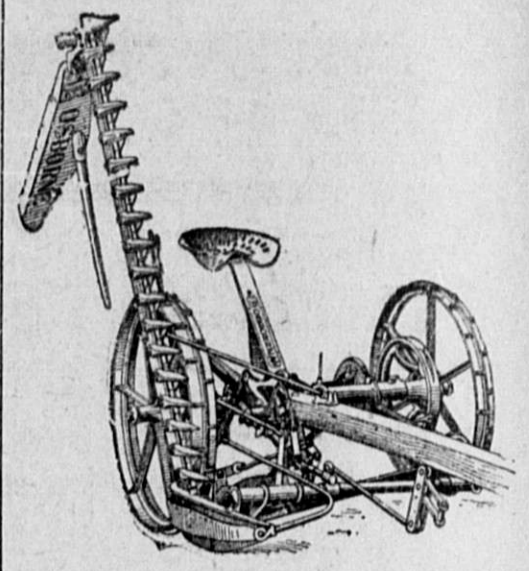

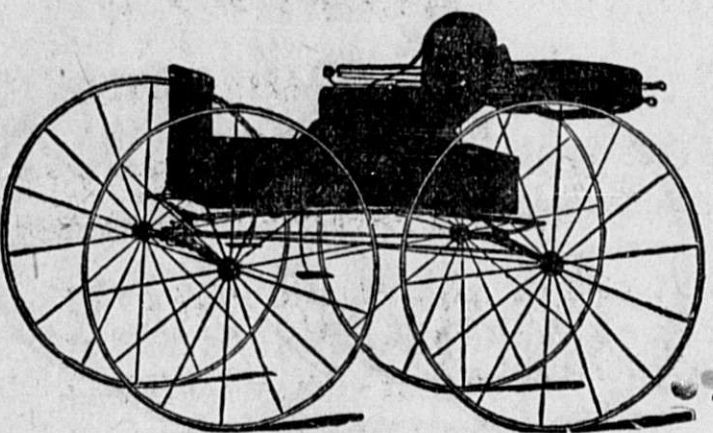

### State Fair Land Show.

The Michigan State Fair Land Show will be a leading feature of the Michigan State Fair which opens September 16th next and runs for a week. Arrangements for the creation of this portion of the great State Fair have just been concluded and the land exhibit promises to be quite as interesting as the great Chicago and New York land shows which attract from 250,000 to 350,000 visitors. The State Fair management created a show building by utilizing all that space under the grand stand formerly occupied by the betting rings, the bar and small concessions. This space has been nicely boarded and a large awning will extend along the front. The space of 400x40 feet floor space will be occupied and this with the wall space will provide room for a goodly number of splendid exhibits which have been offered by the great railroads covering the North, the East, the West and the South. Every product of these many districts will be shown as will also the products of Michigan. There will be the fruits from California, the wheat from Canada, the cotton from the sunny southland, the alfalfa from the west, and all other agricultural products of the entire country. As this will be the first and only land show at any state fair it may safely be said to be another innovation for Michigan, home of so many innovations for this year. The exhibits will all be tastefully arranged and the populace will be able to walk in and out among them to gain a close view of the splendid products of all America. It is proposed to make the land show a permanent feature of the Michigan State Fair and to provide another year a much larger space to care for the exhibitors. Some promoters had planned to give Detroit such an exhibit but the management of the State Fair secured the splendid feature and quickly added it to the many new attractions to be seen only in Michigan.
