



This laugh. caused the Greeks and some of the others to laugh at Lucullus, who commanded Mithradates to resign the office upon peril of war with the Romans. Mithradates intimated that he would resign, but he kept putting it off until he had Lucullus, who hesitated to oppose so small a country as Phrygia with the legions of Rome, trying to pad time in every way that he could.
