W. N. Miller of Farmington, Mich., founder of The Tawas Herald, spent the week end visiting old friends in the city. Mr. Miller is publisher of the Farmington Enterprise.

The first number of The Tawas Herald was issued by Mr. Miller January 10, 1884. About 35 years ago it was purchased by M. J. Murphy, who was succeeded by Len J. Patterson and he 12 years ago, by Jas. E. Ballard, the present owner. The news in the first number. Passenger service had just been opened on the Detroit, Bay City & Alpena railroad. The road had been extended to Alger and Oscoda. It was forecast that the railroad would lead to a great development of the country which had been before impracticable.

Pringle and Mrs. Hattie Curry, trustees. Mrs. Baguley and Mrs. Curry were elected members of the board of education at the annual school meeting held Monday, July 13.

The following communication was received from the board of education. Tawas City Public Schools will reopen Tuesday, September 8, with an efficient and experienced corps of University teachers in high school and life certificate grade teachers.

A highly favorable letter from Secretary Edmondson of the University committee on diploma schools has just been received, again placing the above school on the accredited list of the University of Michigan until June 30, 1927.

ROACH WINS STATE ALL AROUND CHAMPIONSHIP

At the state gun tournament held at Lansing last Friday and Saturday, Wilbur C. Roach won some high shooting honors, winning the state all-around championship, which included amateurs and professionals, and the state championship in doubles. He tied for first place in the handicap and second place in the 200 singles championship.

The following are the results in the different shooting events:

First in doubles championship, 25 pairs of birds. Roach made 46 out of a possible 50 birds.

Tied in 100 singles handicap, shooting from 22 yards. Broke 96 birds. Lost on shoot off.

Second in 200 singles championship. First place won by Carl Maust of Detroit who broke 197 birds. Roach broke 196 birds.

Roach in breaking 338 birds out of a possible 350 in the above events won the all-around state championship of Michigan.

He brought home the championship medal in the doubles; chest of silver and clock, second premiums in the handicap and singles, and a trophy in the state all-around championship.

Mrs. Roach won ladies' handicap Saturday, breaking 92 birds out of a possible 100. She lost for first place in state singles championship. She hit 180 birds out of a possible 200.

Mrs. Nan Vogel of Detroit won first place by breaking 181 birds.

There were 183 amateurs and professionals at the Lansing meet from this and other states. There were six women shooters. Over 33,000 shots were fired, requiring nearly two tons of shot. This was said to be one of the biggest shooting events ever held in Michigan.

FORMING HABITS

IN A broad sense, habit may be termed the element of conscious or unconscious persistence.

Some habits are opposed to noble growth, such as indolence, indifference to lofty impressions, forgetfulness, the acquirement of ragged tempers, vulgar speech, failure to adapt one's self to new circumstances, fault-finding and the common habit of thinking evil of one's friends and neighbors.

There are hundreds of such habits which are opposed to the development of the best there is in us, ruinous alike to our future careers and contentment.

By following a train of wrong ideas again and again, we gradually lose our ability to distinguish evil from good.

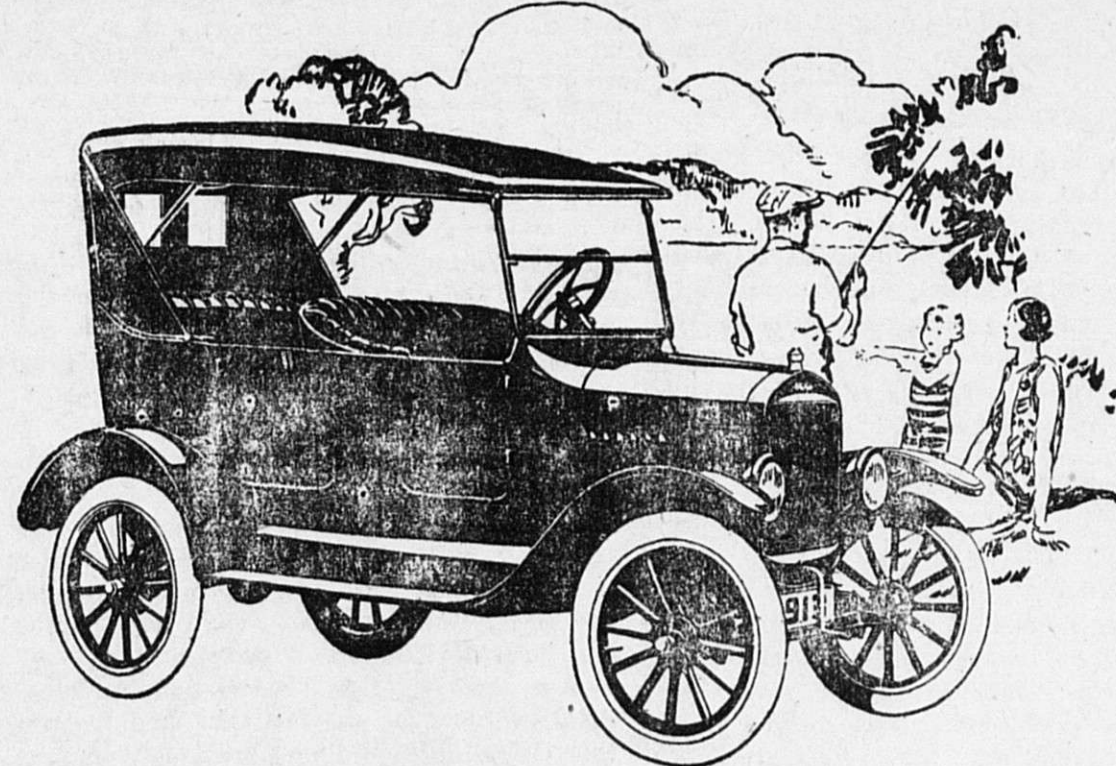
