## HORSE-AUTO CRASH FATAL TO RIDER

Charles T. Thornton, night watchman at the Detroit & Mackinac railroad shops, was fatally injured at about six o'clock Saturday evening when the horse he was riding was hit by a car driven by Rev. J. W. LeVan. The accident occurred at the intersection of Second Street and Sixth Avenue. Mr. Thornton was taken into the hospital where it was found that he was very seriously injured. He died about two hours later while being taken to the hospital at Omer.

Charles Thomas Thornton was born October 26, 1856, at Woodstock, Canada. He was united in marriage to Luella Lavina Cook, January 12, 1880, who preceded him in death May 30, 1896 at Kalkaska, Mich. To this union six children were born, five of whom are living.

On October 20, 1897, he was united in marriage to Mrs. Jennie Stage of Kalkaska, who died at Prescott March 30, 1906. To this union were born two daughters, one of whom died in 1911 at Tawas City.

The deceased is survived by six children, Mrs. C. E. Lickfelt of Tawas City, Mrs. George Lickfelt of Prescott, C. Milner Thornton of Port Huron, John W. Thornton of Detroit, Milton W. Thornton of Detroit and Mrs. John W. Ward of Tawas City.

The funeral services were held at two o'clock Thursday afternoon at Crosswell, Mich.

The deceased had been a resident of Iosco county for many years.

Andrew William Cecil, age 54 years, one month and seven days, died Wednesday, November 21, at the home of his son, Ernest Cecil, at Tawasville. He had been ailing but a few months, death being due to heart trouble.

We have driven over the Isoco county roads and find the same in fine condition. The road from U. S. No. 23 to Long Lake, the Plank, the Esmond, Thompson, and Meadow, Alabaster, Sand Lake, Sherman road are surely a credit to any county considering the rainy season we are having. The new road from Hale east one mile built this season is in fine condition. The road from Long Lake in Plainfield township north to South Branch of which this county has just built one mile on the south end is in need of a second coat of gravel as there are places where the clay is cutting through and the committee would recommend that a second coat of gravel be put on this year. The road from Long Lake to the Kokosing resort which was started in 1927 was finished this year and we report it in good shape.

We, as a committee, would ask that the county road commissioners would interview the state highway department about building a 9-foot bridge across the AuSable bridge on the AuSable river at AuSable. This is a dangerous bridge and people are endangering their lives while crossing it, when two cars passing. We would further recommend that the commissioner place two red glass at the AuSable bridge on U. S. No. 23. We would further

recommend that the commissioner interview the state highway department in regard to placing slow signs at the Holland Hotel corner and also one at the intersection of the three gravel roads at the village of Hale. We are pleased to note that the new road that the National Forest just completed, also the scenic road along the AuSable river to Oscoda. This road is built by Oscoda township. We would recommend trimming trees and brush out of the old state road from Sullivan's crossing east of D. & M. R. R. to Angell's crossing. This road is used considerably by tourists and the brush and trees are growing by the side of road. We would also ask that on the Alabaster road where the road crosses between Tawas City and Alabaster that the brush be trimmed out on this road, so as to make the road more safe.

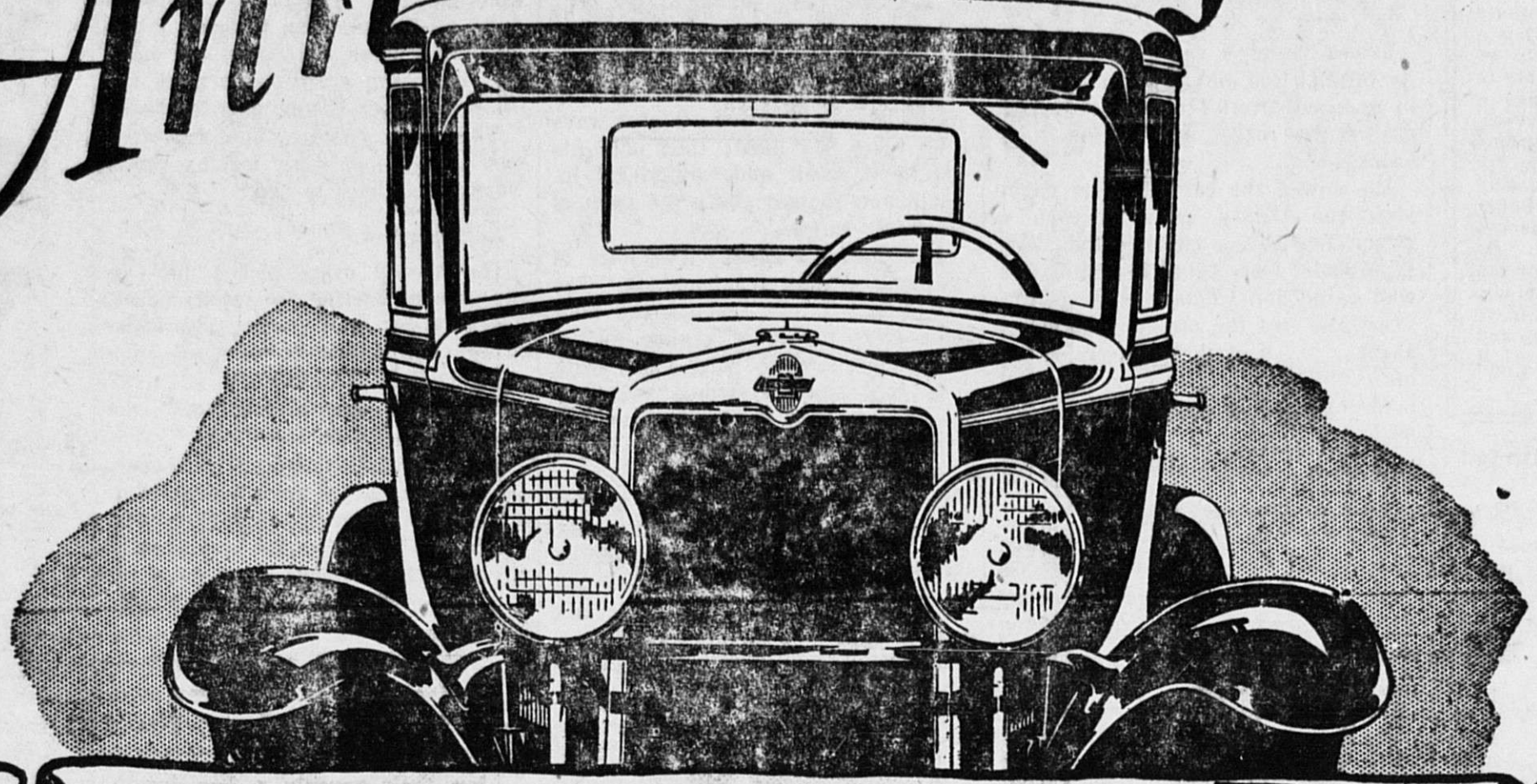

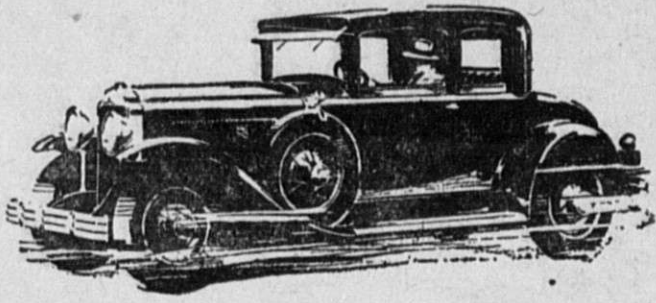

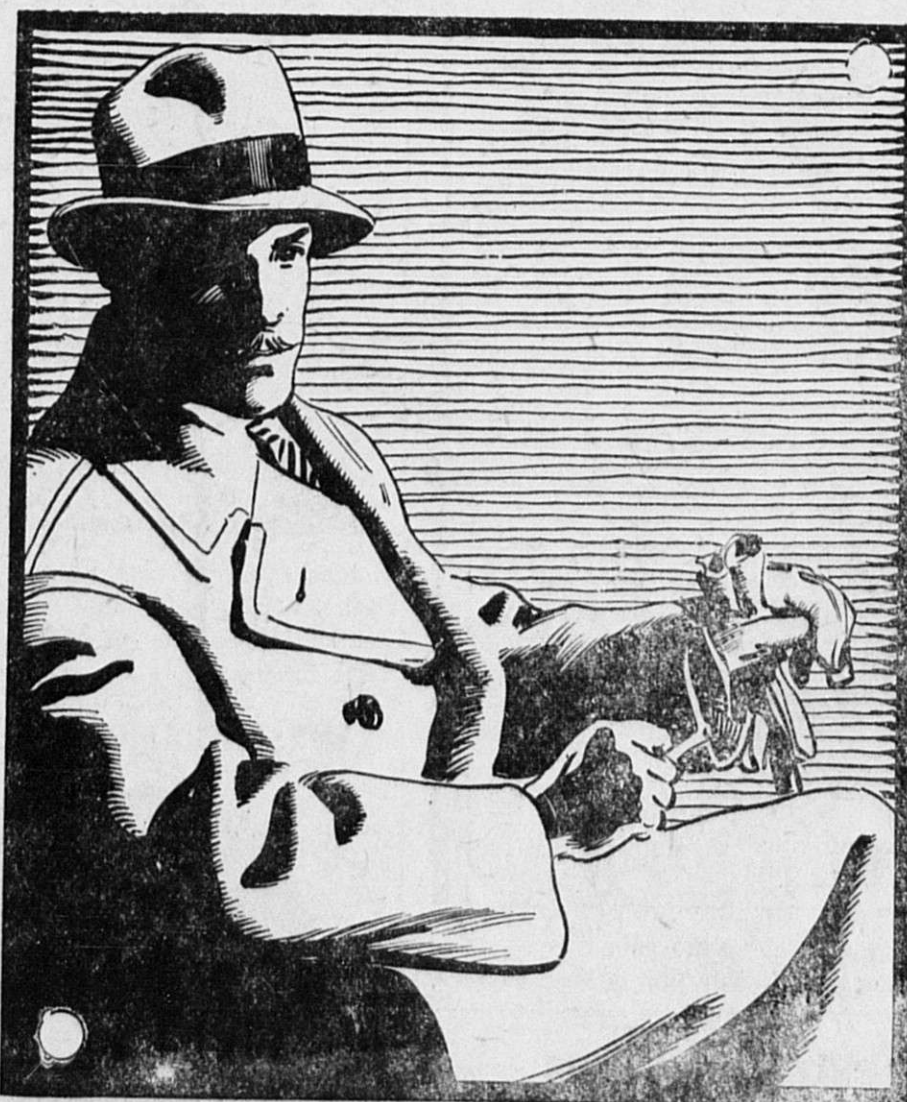
