## LOCAL FIRMS AWARDED THREE OUT OF FIVE NEW JAIL CONSTRUCTION CONTRACTS

### Davison-Rose to Start Work Next Week

Bids Opened Tuesday At Special Meeting of Board of Supervisors

"Early next week we shall start moving our construction equipment on the site and begin preliminary work," stated Edward Davison of Davison-Rose Builders, Incorporated, successful bidder on the general contract for constructing Isco county's new jail. Davison-Rose was one of three local contractors to be awarded contracts on the project.

Bids were opened Tuesday afternoon at a special meeting of the board of supervisors called for the purpose.

Five contracts were awarded. Besides Davison-Rose, the two other local successful bidders were: Northern Plumbing Company of East Tawas, plumbing, and R. A. Myers and Company of East Tawas, heating. Contracts were awarded to Fries and Son of Covington, Kentucky, for jail equipment and York Electric Company of Bay City for electrical work.

Five contractors filed bids seeking the general construction contract. They were: O. J. Schmidt, \$119,937; Vollmer Construction Company of Saginaw, \$119,279; Weber Construction Company of Bay City, \$123,720; Consolidated Construction Company of Bay City, \$115,162; Davison-Rose of Tawas City, \$114,000.

On jail equipment the bids were: Fries and Son of Covington, Kentucky, \$11,500; Stewart Iron Works, Cincinnati, Ohio, \$14,397; Decatur Iron and Steel Company of Decatur, Alabama, \$12,622; Northern Building Company of St. Louis, Missouri, \$14,997; The VanDorn Iron Works, Cleveland, Ohio, \$18,220.

Contractors bidding on the plumbing contract were: Bay City Plumbing and Heating of Bay City, \$18,500; Budd-Burich of Bay City, \$18,776; Goeyette Heating Company of Flint, \$19,775; Kuczarska Plumbing Company of Bay City, \$17,656; Brenske Company of Bay City, \$18,613; Northern Plumbing of East Tawas, \$15,282.

The heating contract bids were: A. C. Klopff and Son of Saginaw, \$11,141; William A. Lange and Son of Saginaw, \$10,500; Frimberger Sheet Metal Company of Alpena, \$9,984; K-R Metal Engineers of Bay City, \$12,455; R. A. Myers and Company of East Tawas, \$9,000.

The electrical contractor bids were as follows: Doran Electric Company of Alpena, \$11,968; Smith-Maynard of Bay City, \$13,857; York Electric of Bay City, \$6,900; Pioneer Electric Company of Bay City, \$10,228.

Construction costs to the county under successful bids will total \$156,682.

Similar in appearance and construction to the new court-house, the new jail and sheriff's quarters will be constructed of concrete blocks with outside walls of Indiana limestone. Fronting the street will be the sheriff's residential quarters and extending to the rear from the main entrance at the central east side of the building will be the departmental offices, cell blocks and garage. The building will be about 193 feet by 49 feet.

The sheriff's quarters will be provided with large living-dining room, two bedrooms, bath and large kitchen.

Departmental offices will include sheriff's office, deputy's office and booking room.

In the jail section will be men's cell block, women's cell block, criminal cells and cells for mental cases. A two-car garage will occupy the extreme rear of the building.

### Open New Insurance Office Here This Week

Russell Church and Harry Goodale opened their new insurance office in the Babcock-Hertzler building this week. The new office is located across from the Isco County Building in Tawas City.

The former insurance office in East Tawas will be taken over by the Rexall Drug Company in an expansion program.

The office now occupied by Church and Goodale was formerly the office of Davison-Rose Builders, Incorporated, which has moved to a new building on the Meadow Road.

### Aims to Have Safe Drivers

The Consumers Power Company aims to have safe and courteous drivers. So, as part of a system-wide program, each of the 44 employees of its Tawas City area who drive company vehicles full or part-time is going to be given a test.

Tests began last Friday under the direction of A. G. Ellico and G. W. Clark, Jr., auto driver-trainers. Albert Duquette, past member of the Michigan State Utility Workers' Council, CIO, was one of the first to take the test, and other employees will follow over a one-week period, five days a week.

Among the group will be Local Manager Gordon Huck. He pointed out that even Justin R. Whiting, Consumers Power chairman of the board, had taken the examinations. Ellico and Clark, who will conduct the tests here, said that about two hours will be devoted to each employee, divided about evenly between written and psycho-physical tests and an actual driving road test. Each driver will be carefully graded on a lengthy check sheet on all portions of the examinations.

When they are completed satisfactorily, the driver will be given a special Consumers driving permit. Any bad driving habits disclosed in the test will be pointed out to the worker, along with physical liabilities uncovered. Methods of compensating for deficiencies will be discussed.

"Since we operate a total of 18 vehicles in this area," Huck explained, "we are anxious to cut the accident rate as far as possible. We feel that workers will cooperate and seek to correct any faults disclosed, since bad driving habits not only endanger themselves but also the public." (See SAFE DRIVING, Back Page)

## New East Branch Bridge Officially Open

Announcement Made By Don Akers, Bridge Project Engineer

"The new bridge over the East Branch of the AuGres river on M-55 will be officially open to the public this noon (Friday)," announced Don Akers, bridge project engineer, Michigan State Highway Department.

Built by the Sargeant Construction Company of Saginaw, it is one of the finest appearing bridges in the county. Started October 15, 1953, 1,142 barrels of cement and nearly 300,000 pounds of steel were used in its construction. Approaches and other excavation work required the moving of 30,000 yards of dirt.

The bridge is 178 feet long and the 28 foot roadway is 32 feet above the stream. An 18 inch safety walk is on each side of the roadway.

The approaches were constructed by William Gilliland Construction Company of Alpena. J. H. Wyatt of Grand Rapids was the sodding contractor.

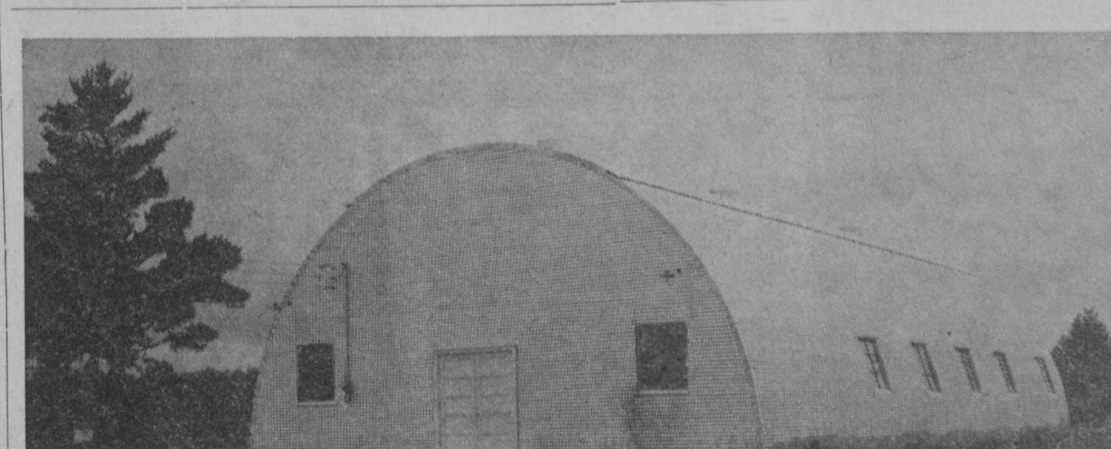
### Mr. and Mrs. Herman Bischoff Celebrate 50th Anniversary

A. Gordon Helmhold, a member of local board No. 36, has suggested that an item published in the "Selective Service," a service paper, be furnished to the newspapers for publication because of its sound advice to young men.

Stay in School! The advice from the Selective Service System to a young man who has not yet completed his high school education has always been and will continue to be for him to stay in school until he completes his high school education. Such was the intent of congress when provision was made for a statutory deferment for a registrant to be deferred until he graduates, attains the age of 20 or ceases to satisfactorily pursue his courses.

"At this particular time of the year many high school students are caught in the cross current of conflicting advice. Some students will abandon their high school education for one of the following reasons:

(1) Jobs are relatively plentiful and wages are lucrative, (2) Dislike of school, (3) Desire to start living, (4) To go back and complete education at a later date, (5) A desire to enlist in the services, (6) Necessity.

The fallacy of the first four arguments above is easily discernible. Now in regard to No. 5, the Department of the Army and the Department of the Air Force have recently released publications advising a young man to remain in school until he completes his high school education.

The Army pamphlet is called "Straight Talk about Staying in School," and the Air Force publication is called "Straight From the Shoulder." In both publications, it is pointed out that the services desire that a young man complete his high school education. It is pointed out that modern warfare demands weapons and techniques of an increasingly complex nature. Specialized and technical training is necessary and the services need men with education and ability to absorb specialized and technical training.

## The Bible Reflects All Eras of History

ONE of the things that has made the Bible's Old Testament so vitally related to human experience, and so persistent in its symbolism, is the fact that every phase of what has happened, and what is happening, to humanity is somewhere found in the record.

Periods and episodes of greatness, prosperity and splendor are interspersed in that history with periods of depression, deep suffering, and utter destruction.

What is amazing is that that ancient history, surveyed against present-day events and conditions, often reads very much like the Twentieth Century. The oppression of the Jews by a hostile Pharaoh in Egypt can be compared with Hitler's attempt utterly to annihilate the Jews in Germany, and to extend that annihilation to every part of the world that he hoped to conquer.

So the Old Testament Scriptures have interest, vividness and significance for discerning readers today, that escapes those who have read them only as records of the past.

What is most deeply significant in those Scriptures, however, is that out of, and in, a world of slavery and bondage, they not only contain the essential idea of freedom, but they reveal the hope, power and persistent spirit of survival.

Not only is it significant that the spirit of freedom persists in a world of bondage, but religiously there is the miracle of the survival of faith, and the aspiration for truth and righteousness.

Despite the deep-dyed sins of nation and individuals, what shines forth is a pure and perfect aspiration for God, and a sublime devotion to the commonweal.

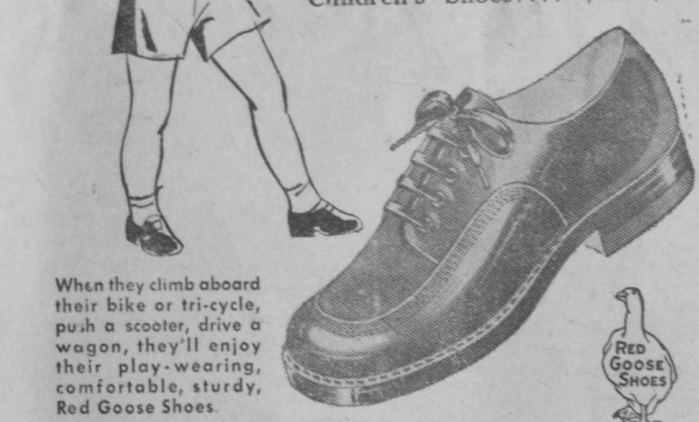

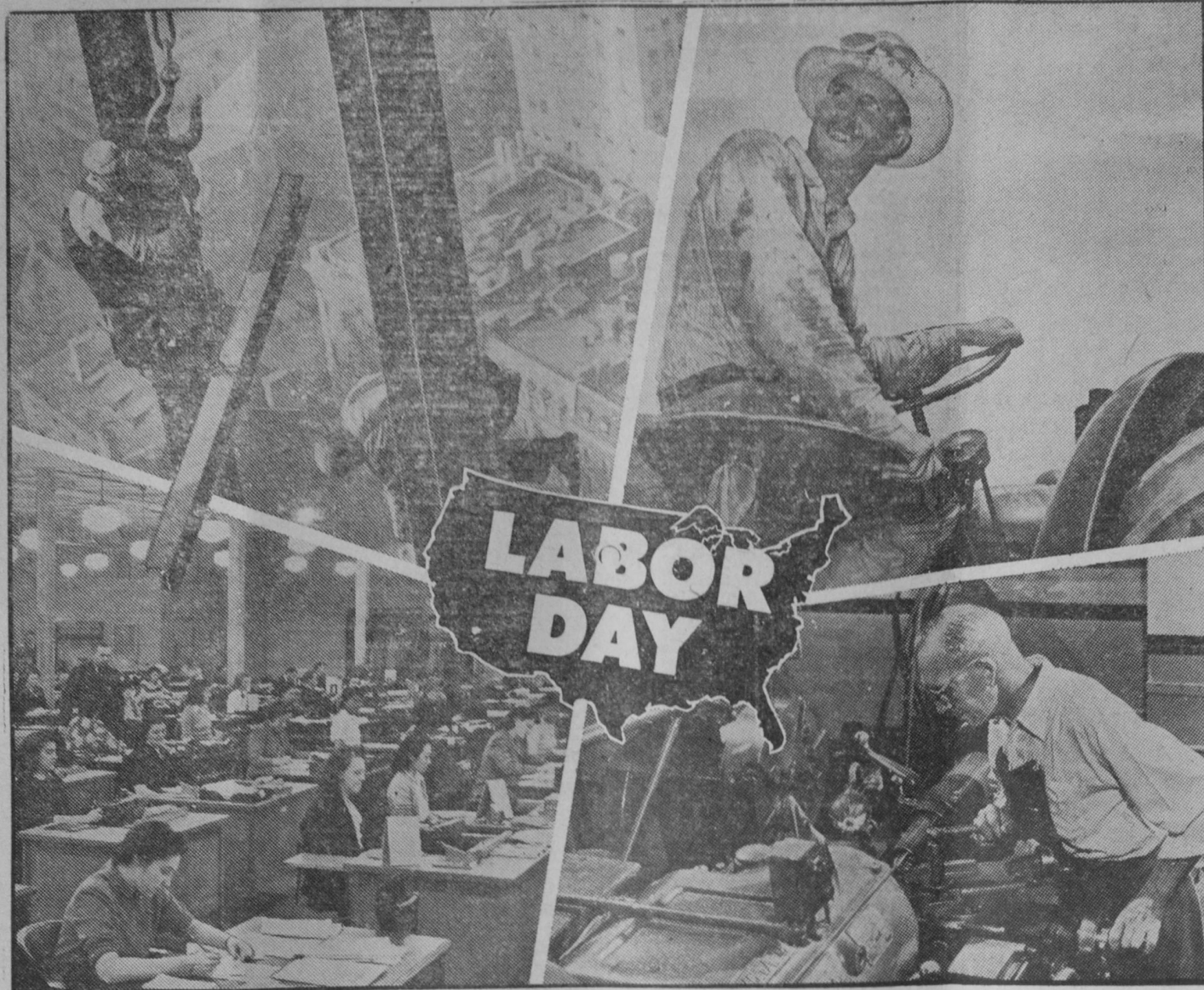
## Arrangements Made for Federal Farm Census

Mr. Rasmussen will direct a force of 23 crew leaders and 205 enumerators in 36 Michigan counties from the Ludington office. Counties to be covered from Ludington include Alcona, Alpena, Antrim, Arenac, Bay, Benzie, Charlevoix, Cheboygan, Clare, Crawford, Emmet, Gladwin, Grand Traverse, Iosco, Isabella, Kalkaska, Kent, Lake, Leelanau, Manistee, Mason, Mecosta, Midland, Missaukee, Montmorency, Muskegon, Newaygo, Oceana, Ogemaw, Osceola, Oscoda, Otsego, Ottawa, Presque Isle, Roscommon and Wexford.

Both Mr. Rasmussen and Miss Sergeson reported on August 23 to the permanent Census Bureau district office at Chicago for a week's training. The training covered administrative procedure, office routine, map work, practice in filling out farm census report forms and other duties and responsibilities connected with the job.

The 1954 Census of Agriculture will provide information on the number and size of farms, acreage and harvest of crops, livestock production and inventories, selected farm facilities and equipment, selected farm expenditures, farm values and mortgage debt.

## Coast Guard Places Emphasis on Overcrowding Boats

The United States Coast Guard on the Great Lakes is making plans for an anticipated high volume of pleasure boating during the 1954 Labor Day weekend.

Coast Guard stations on the Lakes will stress safety to the boating public placing emphasis on overloading of boats, negligent and reckless operation, use of life jackets and particularly the right size jackets in the case of children.

The commander of the Ninth Coast Guard District asks all yacht clubs, small boat rental agencies and civic organizations interested in safe boating to assist in this educational program to make the 1954 Labor Day weekend the safest on record.

The commander said that some accidents can be avoided and sets forth some suggestions for safe operations.

Do not overload your boat. Do not leave shore in a leaky or poorly constructed boat.

Liquor and safe boating do not mix.

Observe the pilot rules. Instruct at least one of your passengers or "crew" in the rudiments of handling your boat if you should become disabled, and without alarming them, see that all hands know what to do in an emergency. Show all hands the location of emergency equipment.

Don't hurry when operating your boat or when securing equipment and supplies for it—take your time and use caution.

Obtain local information and familiarize yourself with the locality in which you are going to operate your boat. Do not venture into dangerous or restricted waters.

Have life preservers readily available and wear when conditions warrant.

Check your weather before going out and have due regard for it.

Gasoline filler pipes outside of combing and extending to bottom of gas tanks.

Fuel tanks vented. Bilges free from oil, waste grease, etc.

Electrical equipment and wiring in accordance with good marine practices.

Have adequate fuel filter. Check your battery and its ventilation.

Do not operate near swimmers in the water.

Do not use gasoline stoves. Do not use kapok-filled life preservers to sit upon, as such action compresses the filler and reduces its efficiency.

Do not fail to provide lifebelts for children.

Do not be afraid of a boat—respect it.

Do not forget your wake can damage others.

Do not fail to reduce speed through anchorage areas.

Do not lie at anchor with short cable; allow sufficient scope.

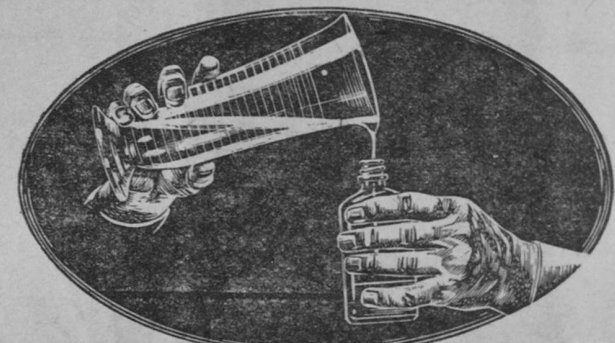

The other day we saw a very interesting picture series—the kind that would be a wonderful addition to any family album. We'd like to pass the idea along to you.

First, there was the picture of mother leaning over, holding up baby's arms while baby put out his foot experimentally. The picture was taken on the lawn with a hedge which had recently been planted in the background. That was the first picture. Every year to the day after that, mother and child stood in the same spot for another picture. The first few years, the hedge had it all over the child in growth. But in the last picture, taken this year, the boy, now seventeen, towers over both his mother and the hedge. It looks as if in another year or two he might be able to reach down and hold on to his mother with HER hands above her head. This picture series took no par-

ticular skill. It was snapped in bright sunlight. The images were clear—they had been taken at a distance of six feet for the earlier pictures, and eight feet for the last three or four. They were all snapped with the same camera too, an ordinary box-type that was inexpensive when it was bought and is still in good use.

The investment in the camera was nothing compared with the enjoyment this family gets in taking out just this one picture series to show their friends.

It is the kind of series any family would like, and can easily take. Along with the usual birthday and Christmas snapshots, it'll give you a wonderfully vivid record of how the children grow. It's a little like the old-fashioned idea of measuring and marking it on the kitchen wall—but a lot more fun.

**HDA NOTES**

You can figure on getting from 18 to 24 quarts of canned peaches from one bushel (48) pounds of fresh fruit.

So, check your market right away to see whether or not they have a good buy for the canning or freezing of peaches. Reports are that Michigan peaches are in good, plentiful in supply, and that prices have been cut because so many of them have ripened at one time (due to unseasonably hot weather, no doubt). Folks in the "peach area" are urging home makers to buy now while the supply is greatest, the price lowest.

To freeze, look for J. H. Hale, Hale Haven, Elberta or Red Haven varieties. Rapid preparation is so very essential to prevent peaches from browning. Peel, remove pits and cut each half in four to six pieces. Pack pieces quickly into containers and leave as little headspace as possible.

Cover the fruit with a 50 percent syrup containing ascorbic acid (buy it at your drug store in tablet form). Add 1,000 milligrams to cool syrup just before pouring over fruit. Freeze at once.

To can, remove skins (usually preceded by a boiling water dip). Can as slices or halves using either the hot pack or cold pack method. Hot pack means to heat peaches in hot syrup, filling jars (leave headspace), and processing in the hot water bath for 20 minutes. Cold pack means to place the raw peaches into jars, cover with boiling water, and process in the hot water bath, 25 minutes for pints, 35 minutes for quarts.

Have you made ice tea by the refrigerator method? Use two teaspoons of tea for each cup of water. Pour cold water over the tea and let it stand overnight in a covered jar in the refrigerator. Strain and pour over ice.

When you buy a powdered household bleach these days, be sure to check whether it is a mild bleach or a strong one before you use it. Until recently, the only powdered bleach available was a mild one made of sodium perborate. But, a newer, dry calcium hypochlorite bleach is now available for heavy-duty work. Do not confuse the two. Each kind has its place, and either one will make you unhappy if you use it for the wrong fabric.

Several factors cause canned fruit to float in jars. Fruit may float because the syrup is too heavy, because the pack is too loose, or because all the air in the fruit tissues was forced out during the heating and processing.

**County Agent News**

When I visited with Ernest Bellen of Burleigh township last week he said he was drenching his ewes and lambs with phenothiazine-lead arsenate. That is a good management practice and is highly recommended, but only twice each year or every six months. I know that Ernest is an old hand at raising livestock and agrees that parasite control is absolutely necessary to get those economical gains on his lambs that are on pasture. There isn't any one thing that gets those economical gains on lambs. It requires a combination of good pasture, a breeding program using sound ewes and good type rams, parasite control and a handy farmer at lambing time.

I can't help but remark about the "Edie" dairy herd when I speak of good selection of animals for production. Whether it be lamb, beef, milk or poultry that good inheritance is a starting point in a good farming program. As I periodically see dairy herds like Edie's using artificial insemination to get that "top" inheritance I wonder why more of our dairymen don't use it?

Just look around you. I dare say that every dairy herd with cows producing over 300 pounds of butterfat each year have cattle that have their inheritance traced back to A. B. A. stock. This inheritance, in turn, can also be traced to our registered dairy cattle breeders who have been to the place where those proven sires are raised. No words were ever spoken that "a dairy bull is half the herd." The same thing can be said for beef cattle and for our sheep raisers, too.

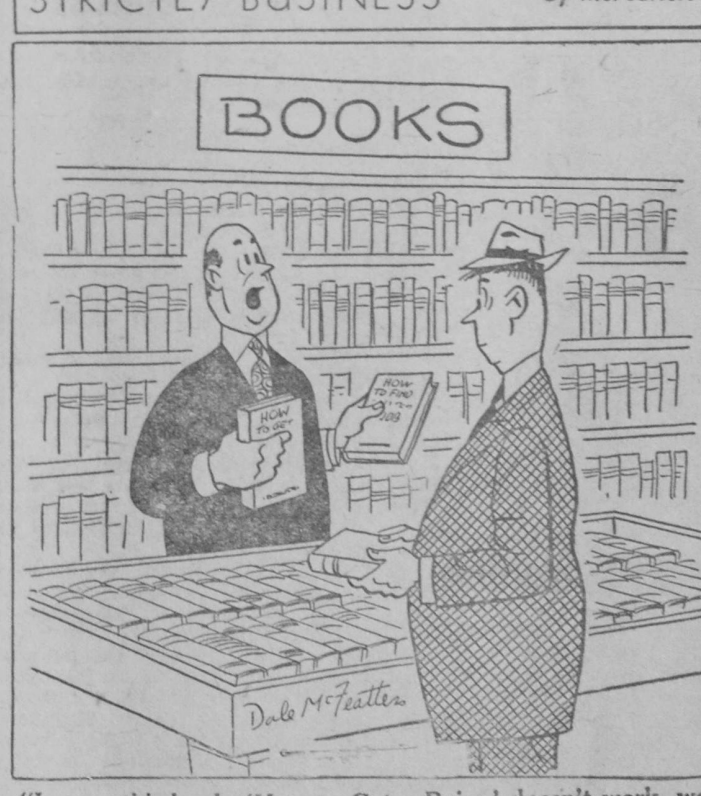

**Child Traffic Safety Responsibility of Everyone**

Child traffic safety education is a continuing process and is the responsibility of all of us, according to Sergeant Joseph Chaput, commanding officer of the East Tawas post of the Michigan State Police.

Sergeant Chaput offered his comment in connection with the current statewide child safety campaign being conducted by police agencies and safety groups.

"Children should be taught the rules of safety as soon as they are able to understand, but these rules must be repeatedly emphasized and kept in their minds as they grow older for they will forget and they will be careless," Sergeant Chaput said. "Furthermore it is extremely important for older persons to set good examples as the children do what grownups do."

There were 100 child pedestrian deaths in Michigan in 1953 and 18 were killed riding bicycles. In addition, 3,600 children were injured.

"Most child pedestrian deaths in the five to 14 year age group occur in residential areas," Sgt. Chaput said. "Crossing between

intersections accounted for 56 percent last year. Other frequent causes were stepping from behind parked cars and walking unsafely or playing in the roadway.

Bicyclists lost their lives entering highways without stopping, at fault in accidents, but swerving, riding double, stunting, and riding at night without proper lighting equipment."

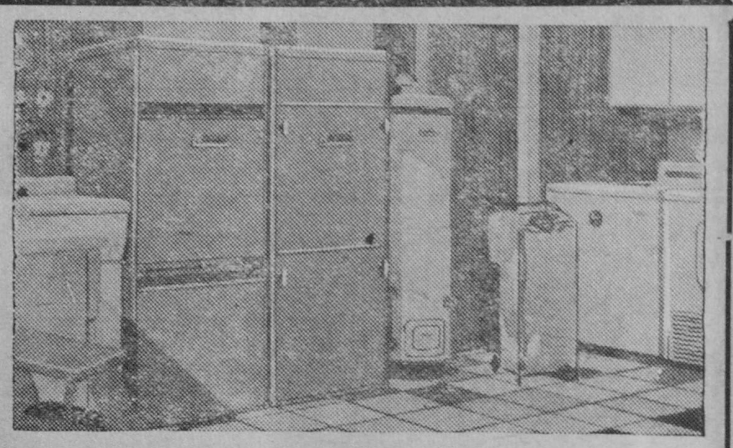
Sergeant Chaput pointed out that the slogan of the campaign, "Watch Out For Kids," is directed to drivers. They are asked to remember that children often do the unexpected and they should help do their safety thinking for them. "Drivers are not always at fault in accidents, but whether they are or not does not bring back a dead child or relieve the pain of an injured one," Sergeant Chaput said.

(Continued from First Page) ger others, but also the employees themselves." Huck said the written examination is designed to evaluate the driver's knowledge of the "rules of the road."

The physical examination consists of tests for visual acuity, field of vision, depth and color perception, night and glare vision, and glare recovery. A road test will also be given. Mapped out with the aid of County Sheriff Ivan O'Farrell, it will cover a 10-mile route providing as many different driving conditions as possible. A brake reaction test will be made on M-55, west of town. A detonator, attached to a wheel will be exploded automatically, and the driver must bring the car to a halt as soon as possible.

Especially rigged, the testing device shows how long it takes the driver to get his foot from the accelerator pedal to the brake and then how long is required to bring the car to a full stop. Concluding the road test is a parking check. The driver is required to back the car in a parking place only four feet greater than the length of the car.

Huck said that outside of promoting safer driving habits, another objective of the program is to encourage courteous driving so it will become habitual with all Consumers workers who operate vehicles. He revealed also that it was planned to make periodic tests so the safe driving program will be continuous.

## 700 School Children to be Guests September 25 at Wurtsmith Air Base

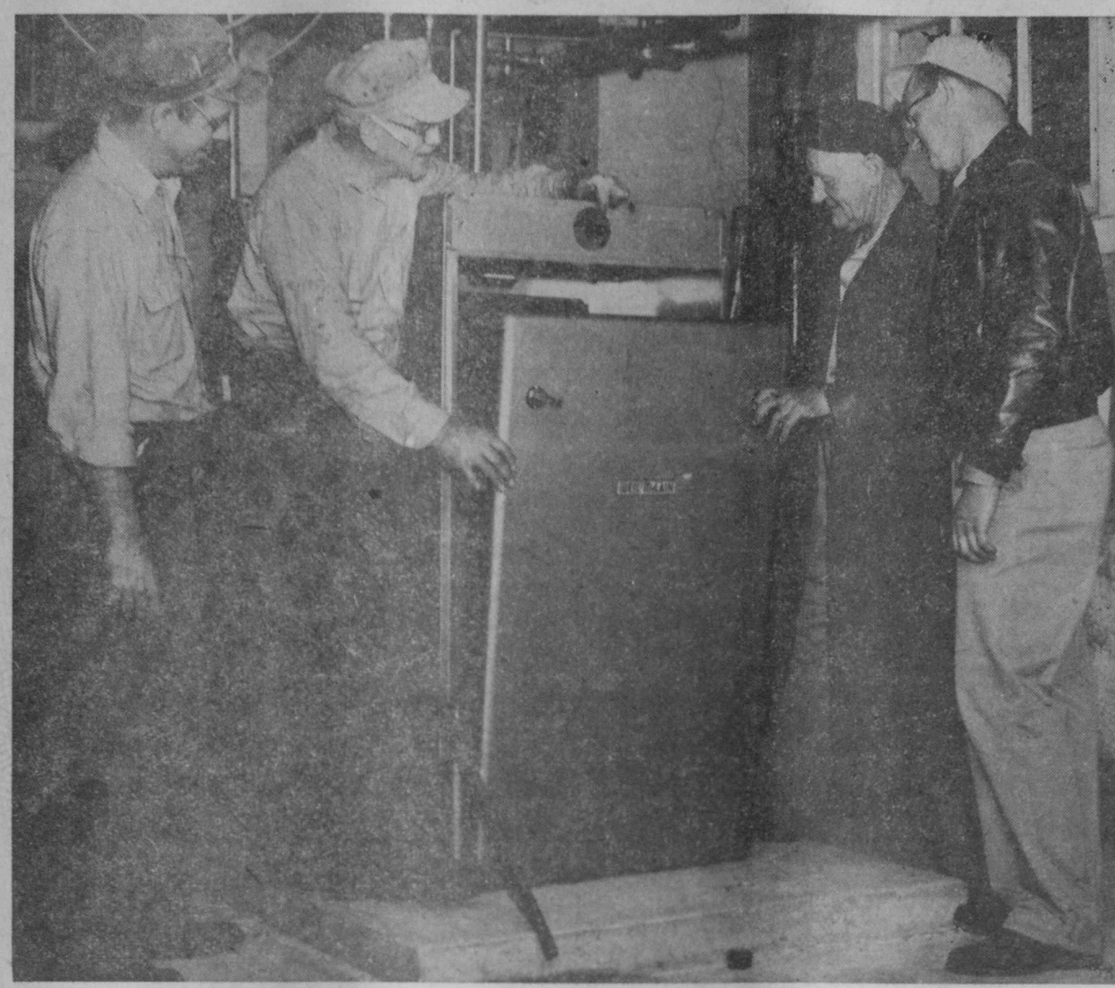

Charles H. Hill, plant manager for National Gypsum Company, announced that a new calcining system will be put into operation at the National City, Michigan, plant. The contract for installation of this system has been awarded to Sorenson-Cross Construction Company of Flint. Calcining is the process whereby 75 percent of the moisture is removed from the raw crushed gypsum by boiling the rock. After calcination, the product is commonly known as plaster of paris.

Commenting on the move, Hill said, "This new calcining process will enable us to control quality more effectively with a minimum of effort. It will also make possible a more efficient manufacturing operation."

Hill declined to estimate the cost of installing the new system.

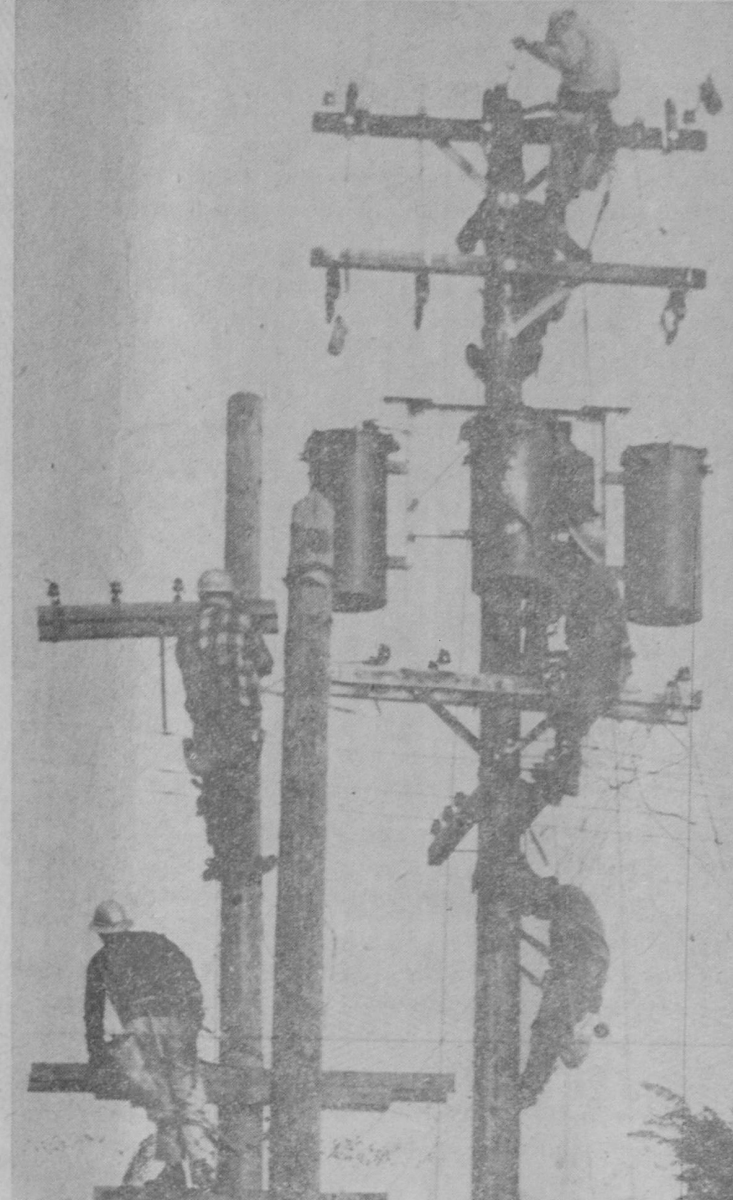
