Recommend Priority For Vaccine

The Michigan State Medical Society recommended a voluntary priority system for the early supply of Salk polio vaccine, should the heretofore experimental project be found acceptable for commercial use.

"If the Salk vaccine is licensed and released for use, doctors of medicine are urged to reserve the commercially available supply for (a) children below first grade level and over one year of age, (b) school children in grades three through eight, and (c) pregnant women," Robert H. Baker, M. D., of Pontiac, MSMS president stated in a letter received by all members of the state society.

The voluntary controls would be necessary only until the nation's drug manufacturers could make enough vaccine to supply the public demand, Dr. Baker explained, and would apply only to the limited initial supply commercially available for administration by private physicians.

If the Salk vaccine is released for use, the National Foundation for Infantile Paralysis will use much of the available supply to vaccinate first and second grade children without charge in schools throughout the nation.

Dr. Baker further stated that there must be a "conscientious effort" to inform the public of the temporary need for voluntary control of the available commercial supply, and that local communities "should be alerted to the need for providing methods to administer the vaccine to persons in the priority groups who are unable to pay."

The evaluation of the 1954 field trials of the Salk vaccine were released Tuesday by the University of Michigan. After that the product may be licensed for commercial use if the United States Public Health Service is satisfied that it is safe and effective.

Conducts Survey of Tourist Program

The East Michigan Tourist Association is conducting a survey to evaluate the promotional program of the East Michigan Winter Sports Council, according to Frank Davis, secretary-manager of the association.

Mr. Davis said that the association is sending out 1,500 letters to people who have written in requesting Michigan winter sports information as a result of the council's program. A brief questionnaire is enclosed asking the person whether he actually came and how many days he enjoyed winter sports.

He said of all of Michigan activities, winter sports showed the greatest growth in popularity and additional information is needed so that the council can plan intelligently on how to promote this business.

The Golden Text is from Mark (10:45): "The Son of man came not to be ministered unto, but to minister, and to give his life a ransom for many."

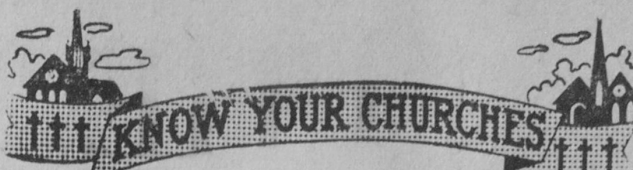

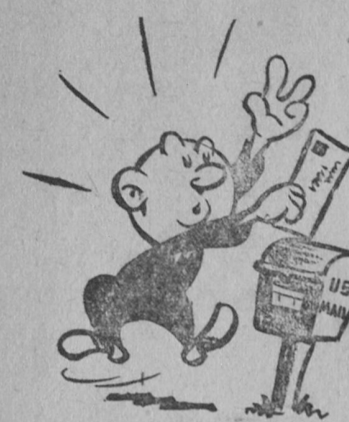

**LEGISLATIVE
NEWS LETTER**

House of Representatives
Lansing, Michigan

An important amendment to
the house rules and one which is
well worth mentioning at this
time, is proposed in house resolu-
tion No. 23, now under consid-
eration in the house rules and
resolutions committee. The resolu-
tion, which undoubtedly will be
adopted prior to adjournment,
proposes to add a new rule,
(Rule 80) spelling out how
ways, when and by whom rep-
resentatives-elect will be sworn
in. The proposed rule makes it
mandatory for the oath of office
to be administered in the house
chamber on the opening day of
the first regular session, or as
soon thereafter as the representa-
tive-elect appears, by a justice
of the supreme court, the speaker
or the clerk of the house, unless
otherwise directed. The senate is
considering a similar amend-
ment to their rules.

H. B. 262 allowing the use of
non-caloric sweeteners in foods
and beverages kicked up quite a
storm and came in for more than
the usual amount of debate be-
cause it was misunderstood, but
was finally passed without a
dissenting vote. Beverages and
foods, including ice cream, hav-
ing the sugar substitute for use
of diabetics and others on strict
health food diets, are plainly
marked on the labels.

The house unanimously passed
H. B. 141 allowing municipal
authorities to enter into agree-
ments with other cities to es-
tablish and operate common dog
pounds.

By a vote of 99 to 0, the house
approved H. B. 201, increasing
license fees for outstate chiro-
practic applicants. The bill also
allows a per diem increase for
members of the board governing
this profession.

The house approved H. B. 153
increasing the fees of chiro-
podists, and also raising the per
diem compensation of board
members.

H. B. 109 was unanimously
passed and sent to the senate
also. As amended, the bill sets
up a legislative committee to act
in an advisory capacity to the
state highway department in
making a study and recommend-
ing to the legislature, the utiliza-
tion or disposition of the state
ferry boats upon completion of
the Straits Bridge. An appropria-
tion of \$20,000 from the Mackinac
Straits Ferry Revolving Fund is
made to the state highway de-
partment to defray the costs of
such a study.

With but one dissenting vote,
the house passed H. B. 180,
which amends the Trailer Coach
Park Act by increasing the
monthly license fee for each
trailer coach in the park from
the present \$1.50 to \$2.50. The
monthly fee is split three ways,
with 50 cents credited to the mu-
nicipality, 50 cents to the county
treasurer and \$1.50 to the school
board or boards for the district
or districts in which same is
parked.

H. B. 157, appropriating \$37,000
to the regents of the University
of Michigan, to be used for ex-
penses incident to a complete
study as to the advisability of,
and costs of instituting a branch
of the university at Flint in con-
nection with the Flint Junior
College, was referred back to the
ways and means committee for
further study.

H. B. 175, easing the restric-
tions on trucks hauling corru-
gated pipe, was also passed by
the house with three yeas. To
spare, proponents having must-
ered 59 votes to the opposition's
28. The bill would permit haulers
of corrugated pipe the same
limits as now allowed haulers of
logs and concrete pipes.

H. B. 248, passed by the house
with a vote of 100 to 9, provides
a means of determining who is to
pay for the installation and
maintenance of safety devices
(flashing light signals) at rail-
road crossings.

H. B. 416, amending the Busi-
ness Receipts Tax Act, has been
introduced. The four salient
points in the amendatory bill
are:

1. Base rate changes from four
to seven mills.

2. Public utility rate changes
from one to two mills.

3. The formula for multi-
state business is changed from a
single factor formula to a three-
factor formula.

4. Depreciation is allowed as a
deductible factor, on the theory
that depreciation in no way coin-
cides with the theory of an added
value tax.

As amended, the bill is de-
signed to bring in approximately
30 million in additional revenues
over what the present bill
brings in for a total of 60 mil-
lion. After discussions with the
appropriating committees, the
conclusion is that approximately
30 million dollars is the absolute
minimum in new revenue which
is needed.

Other measures introduced in-
clude:

HJR "P", proposing an amend-
ment to the constitution to en-
large the state board of educa-
tion and create the office of
state superintendent of educa-
tion. The state superintendent to
be appointed by the board.

H. B. 406 setting up procedure
for annexation of additional land
to metropolitan districts.

H. B. 410 providing for ad-
mission permits to state parks
during the period May 1 to the
first Sunday after Labor Day,
with the revenues derived there-
from earmarked for capital im-
provements of parks.

NO TAX ON VA BENEFITS—
The Veterans Administration is
reminding veterans that VA
benefits payments they have re-
ceived need not be counted in
figuring their federal income
taxes. Death benefits to families
of deceased veterans also are ex-
empt from federal taxation.

reported to the American Guern-
sey Cattle Club for approval and
publication.

**White Cane Week to be
Observed in Michigan**

White Cane Week will be ob-
served in Michigan from April
24 through 30 this year. Local
schools will assist in this educa-
tional effort by distributing
printed leaflets which have been
prepared and furnished by Lions
Clubs of Michigan in cooperation
with the AuGres Lions Club.
"Pat" Hill, chairman of White
Cane Week, announces that a
delegation from AuGres Lions
Club will visit Tawas City, East
Tawas, Whittemore and Hale on
Wednesday, April 27.

Thousands of white canes have
been furnished free of charge to
blind people all over the state. It
is the aim and plan of the Lions
to provide every blind person
with a white cane, "the symbol
of blindness," as a measure of
protection for him.

State legislation in 1936 in-
cluded an ordinance granting the
white cane. The purpose of
right of way to a person carrying
White Cane Week is, primarily,
an educational one—working
toward that day when all our
citizens will know and recognize
the white cane as the symbol of
blindness, and will give under-
standing and courteous as-
sistance to bearers of the white
cane whenever such opportuni-
ties present themselves.

Lambing season is in full
swing. I visited with William
White, Lyle Robinson, Lester
Robinson and his son, Donald,
Arthur Aulerich, Edward Robin-
son, Robert Wrathel, Martin and
Harold Siegrist, John Cobb,
Henry Fahselt, Phillip Watts and
George Lake, also with G. L.
Clary about the sheep program.
All of us are thinking about
parasite control, managing our
pastures and finishing this year's
fat lamb crop for the highest
market dollar.

"When do our lamb pools be-
gin?" That was a frequent
question that can be answered by
telling you the first lamb pool is
tentatively scheduled for August
2 at West Branch. There are
eight pools set up through the
months of August, September,
October, November and Decem-
ber to serve all sheep raisers who
want to bring their lambs.

There is a good number of
Isosco County farmers who are
helping me in demonstrations on
"what will Vernal alfalfa do in
Isosco County?"

Over a year ago I ordered the
seed for this project and enrolled
the assistance of Warren Britt,
Earl Daugharty, Joseph Barnes,
Ralph Harris, Waldo Curry Jr.,
Victor Herriman, Thomas Nelkie,
Martin and Howard Siegrist,
and Howard Britt. May I suggest
you keep these neighbors in mind

and ask them how they like this
new wilt-resistant variety of alf-
alfa?

I have a letter from V. L.
Iraelsen of the Utah Agricultural
Experiment Station at Logan,
Utah. He is asking our Isosco
County farmers to cooperate in
mailing back cards that have
been enclosed in many bags of
alfalfa seed that have been or
will be purchased.

This information will help
them in their seed marketing re-
search program. Give them a
hand, will you?

Chemical weed killers "have
arrived" and they're here to
stay, so farmers in Isosco County
might as well use them with
small fruits and save labor costs.

Use Crag Herbicide at three
pounds per acre about 10 days
after setting strawberry plants.
You may need four pounds on
heavy soil.

It is important that the soil be
moist when the herbicide is ap-
plied. If soil is dry, it is best to
wait for rain or irrigate first and
then spray. Fifty gallons of water
per acre as an over-all spray is
enough for uniform spreading of
the material.

R. F. Carlson, Michigan State
College horticulturist specialist,
advises another three pounds of
Crag after runners have started,
but if weeds get ahead of the
first application of herbicide, use
one-half pound of 2-4-D per acre.

Carlson relates that another
chemical spray for chickweed
and annual bluegrass, Chloro-
IFC, has just been passed by the
Pure Food and Drug Administra-
tion. It is applied in late fall at
the rate of two to three pounds
in 50 gallons of water per acre.

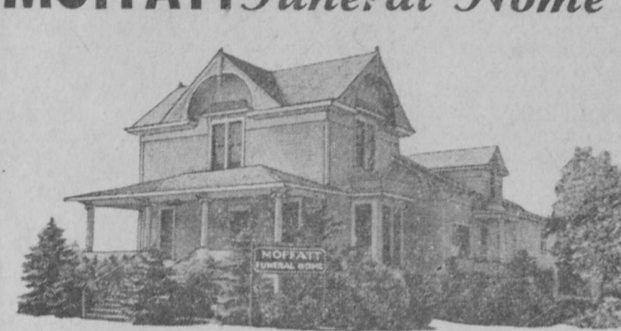

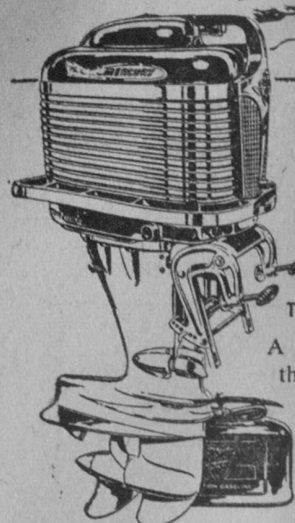

Are you beginning to think about a new project to start this spring as soon as the one you are now working on is completed? How about a conservation project? There are a number of kinds of 4-H Club conservation activities. Are you interested in trees, how to identify them, what the leaves are like, how the barks differ, when to harvest the seeds and how, or maybe how to grow seedling trees and make plantings? Field trips are an important part of this project. You will make a collection of leaves and seeds.

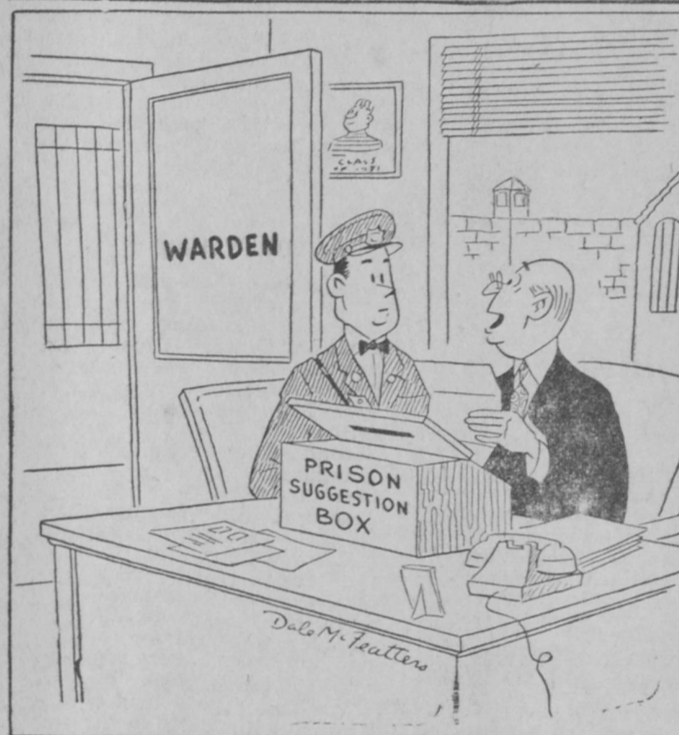
