## Five Promotions Announced by Detroit and Mackinac RR

Promotions of five key executive personnel were announced this week at the general offices of the Detroit and Mackinac Railway Company, Tawas.

Charles Pinkerton, president and general manager of the company, announced Monday that C. R. McMullen had been appointed assistant to the president and general manager and assistant secretary-treasurer, and that Stuart H. White was appointed traffic manager.

E. S. Harris, vice president, of Alpena announced Thursday (today) that James G. Campbell was appointed general superintendent with offices at Tawas City.

Mr. Campbell announced Thursday that William A. Mallon had been assigned to the newly established position of superintendent of operations, and Marvin A. Mallon was appointed superintendent of maintenance.

Mr. McMullen, who had served as superintendent of car service for the past two years, has been with the railroad company 15 years, having started in March 1942.

Mr. White, former general freight agent, a position he held since February 5, 1948, will have jurisdiction over all traffic functions, including the industrial development department. He started with the railway in October 1946.

Mr. Campbell is the former superintendent of maintenance, a position he held 3½ years. He now has overall supervision of maintenance and operations, including maintenance of equipment.

The new superintendent of op-

erations, William A. Mallon, will have charge of train, station and car service operation and personnel. Prior to his new position, he had been general manager of Ottawa Equipment Company for the past year. He has been with the Detroit and Mackinac since April 1950, having held positions as manager of Huron Wood Preserving Company and superintendent of car service.

Marvin Mallon, who will have 21 years of service with the railway effective June 1958, with two years and eight months out for military service during World War II, had been mechanical assistant to the president and general manager since 1946. That position was created when the Detroit and Mackinac put its first diesel locomotives into service in 1946.

## Load Restrictions Effective March 5

Effective 6:00 a. m. March 5, weight restrictions were imposed and enforced on all state trunklines in the Lower Peninsula, except there will be no restrictions on the all-season trunkline highways.

The lone class A all-season highway in this area is US-23, with the exception of the stretch of concrete on M-65 from the US-23 intersection which is also in this all-season category.

## 1958 Tawas City Budget Adopted by Council Monday

A budget of approximately \$80,000 for fiscal 1958 was presented at the Tawas City Council meeting Monday night. The new fiscal year for city business starts March 10.

This was the most detailed budget ever presented to the council for approval in the city's history. It included a complete breakdown of expenditures for the coming year, due principally

to the city's new bookkeeping system which was initiated last spring.

Of the total budget, \$30,000 is to be raised through taxation, or roughly 15 mills on a two million dollar valuation. Millage figures were as follows: Contingent, 1½ mills; street, three mills; park, one-half mill; debt, 1½ mills; interest and sinking, one-half mill.

The city debt fund was lowered one-half mill this year because of the reduction in voted city debts.

Balance of the money to meet the budget will be received on act 51 money from the state, sales tax, intangible tax, trunk-line maintenance, traffic fines and license fees.

The final figure in tax dollars to be raised will be converted from millage by the board of review on March 10, 11 and 12.

Listing some of the city's expenditures, the budget allows \$29,880 for streets, \$1,725 for cemetery, \$5,060 for parks and recreation, \$8,450 for streets and maintenance, \$8,400 for police department, \$2,300 for fire department, \$4,805 for garbage disposal and dump.

Of the \$29,880 listed under streets, \$7,310 is set aside for street construction, \$4,400 for seal coating, \$10,945 for maintenance, \$2,725 for storm sewers and \$4,500 for street lighting.

The \$28,805 for labor included wages of all city employees, police department, councilmen, garbage disposal, supervisors, election help and extra help at the cemetery.

Work on the detailed budget was done by City Superintendent Reginald Bublitz, Clerk Walter Nelson and Treasurer Ruth Al-

bertson. It was accomplished by reviewing invoices for the past year and breaking down expenditures by departments.

The council voted the same salaries for city officers as last year: Clerk, \$600 annually; treasurer, \$100 salary plus one percent collection fees; mayor, \$100; fire chief, \$50, and councilmen, \$2 per meeting. (See COUNCIL, page 8.)

## Feather-Life Has Not Received Loan Yet

A. C. Fried, president of Feather-Life Manufacturing Company, stated Monday that his company had not as yet received the loan from the Small Business Administration as reported last week.

Word was received here last Tuesday from Senator Charles E. Potter and Senator Patrick McNamara that a loan of \$175,000 had been reconsidered and approved.

"All we have so far is the authorization for the loan," stated Mr. Fried. "It is subject to a number of contingencies."

The Detroit executive stated that company officials are now working on a program in order to accept the loan but, he said, in order to clear up any possible misunderstanding in the Tawas area, "we do not have the grant as of this moment."

Mr. Fried expressed his thanks to Senators Potter and McNamara, Congressman Cederberg and business groups of the Tawas for "going to bat for us on this deal."

## \$5,500 Budget for '58 OK'd by Tawas Chamber

A budget of \$5,500 was approved at last week's board of directors meeting of the Tawas Chamber of Commerce. Based on the chamber's dues structure, 30 percent of this 1958 budget will go toward advertising.

Projects and activities in the Tawas area were discussed at Wednesday night's meeting.

Some of these projects included the forming of a water skiing club with a sponsored instructor, sponsoring an athletic director for the summer months and sponsoring Little League ball teams.

Dr. E. B. Cavell and Joseph O'Connor are to work as a committee to follow up the work already started on bait fish and closing Tawas Bay to seining minnows. A letter is to be sent to Lansing with a personal follow-up later.

It was decided to eliminate the water carnival which was held last year. The directors decided that weather conditions were such that any type of power race-

ing on the bay was impracticable. Larry Clute asked that the chamber sponsor a canoe to be used in all canoe races scheduled. He stated the publicity value was very good. This was tabled until the next meeting.

Plans are to be made for the annual banquet and general meeting of the chamber in June. The program is still indefinite.

Members of the National Editorial Association will make stop-overs in the Tawas on July 13 and July 21. Plans are being made through the businessmen's associations to entertain this group of approximately 150.

The fifth annual Tawas River canoe race, sponsored by the Tawas City Businessmen's Association and the chamber, will be held June 22 instead of June 15. The Tawas Bay Yacht Club regatta will be changed from water carnival which was held last year. The directors decided that weather conditions were such that any type of power race-

## Co-Champion Braves Play in District 'B' Final Saturday

Tawas Area Braves ended the regular basketball season as co-champions of the Northeastern Michigan Conference. The Braves ended in a tie for top honors with the Roscommon Bucks, each team

having identical records of 14 wins and two losses.

Annual tournament time starts this week with the Braves competing in the district at Pinconning.

With three class B schools entered at Pinny, Tawas drew a bye the first night of play. On Thursday night the West Branch Orioles will take on Pinconning at 9 o'clock.

The Braves will play the winner of this game Saturday night at 9 o'clock.

All indications point to another battle between the Orioles and the Braves for top district honors. West Branch is heavily favored to win over Pinny in the tournament opener.

This is about the same situation as action in the tourney last year when the Orioles and Braves fought it out the last night of play. West Branch came out the winner in that one. The two

teams have met only once this year, Tawas taking the nod in overtime on the Orioles home floor.

Three class D games will be played, West Branch St. Joseph taking on St. Michael's of Pinconning at 7:30 o'clock Saturday night and St. Mary of Bay City meeting St. John of Essexville at 9 o'clock Friday night. Winners of these two games will meet Saturday night in the finals at 7:30 o'clock.

Paul Gwinn, tournament manager, stated that there will be no spectator chairs on the floor and no reserved seats will be sold. The Pinconning auditorium seats 1,350 persons.

Officials assigned to the tournament by the state athletic association are Eugene Kopec, Albert Meyer, Harry Borucki and Joseph Donnelly. Donnelly and Meyer will handle the class B final.

## Curry Gets Award from Dairymen

A certificate was presented to Waldo J. Curry of Tawas Township by the Michigan Dairy Herd Improvement Association in recognition that his dairy herd had qualified for the "400 Honor Roll."

To qualify for this award, a herd must average 400 pounds or more of butterfat each year for the past five years.

Production by the Curry herd was as follows:

Five year average—12,878 pounds of milk per cow; 452.1 pounds of butterfat per cow.

Current year average—14,805 pounds of milk per cow; 510.8 pounds of butterfat per cow.

The dairy extension staff of Michigan State University presented the certificate in recognition of Mr. Curry's success in breeding, feeding and management of his herd.

## Bargain Town to Open Again Thursday (Today)

Stanley Lane announced this week that Bargain Town, located south of Tawas City on US-23, would re-open for business Thursday (today).

Lane stated that work would start within 60 days on a new 50 by 160 building which is to be located south of the present building. The new quarters will have three times more floor space than the present building.

## BE A SPORT

Adult basketball fans from the Tawas area may be interested to know that Tawas Area School's student council sent a letter of apology to Standish High School this week. The school faculty and student body are embarrassed because of the poor sportsmanship shown on the part of adult fans from this area.

This embarrassment to school officials and youngsters was caused by actions of local ADULT fans at the recent Tawas-Standish basketball game. This newspaper does not deem it necessary to spell out just what happened at the game... the fans who were responsible should realize, by now, that they showed poor judgment and displayed poor sportsmanship.

We ask this question... Is this the sort of an example that adults should set for school-age youngsters? We don't think it is. If adult fans would look at signs posted in the auditorium, they would note that the school asks its student body to display good sportsmanship at all times. This applies to adults, too.

No matter what local fans think about some other school's sportsmanship, or, in their opinion the lack of it, they were entirely wrong and showed poor taste in their treatment of the Standish players and school. Actions of these adult fans reflect right back on our own school system... two wrongs just do not make a right.

There is a vast difference between high school athletics and professional competition. Fans attending high school athletic contests should not get personal with players or coaches on the floor. This holds true for the referees or umpires, too.

Tawas Area High School needs and deserves the support of its local fans. The entire area can be proud of the sportsmanship displayed by the Braves and the school's student body. Let's return the favor, adult fans.

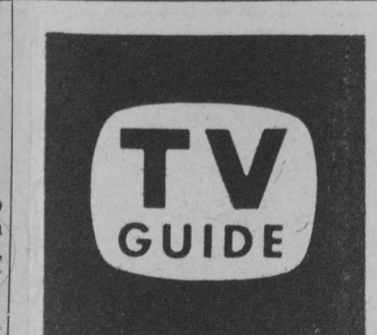

## Cost-Share Aid Applications Now Being Received

Applications for federal cost-share assistance on 1958 conservation practices are being taken at the Iosco County ASC office, Federal Building, East Tawas. No deadline has been set this year for taking these applications, however, those signing early will be considered for preference, along with the need for the practices.

Following are the practices on which cost-share assistance can be earned:

The establishment of a permanent vegetative cover for soil protection or as a needed land-use adjustment; establishment of vegetative cover on acres over that which is normally planted to legumes and grasses; application of liming materials; contour and field strip cropping; planting trees and shrubs for forest purposes, and for erosion control and windbreaks; permanent pasture improvement; spring development and farm pond construction for livestock water; pruning coniferous forest stand of trees; improving timber stands by thinning, release and protection of desirable trees; restocking forest lands with desirable tree species through site preparation and natural regeneration; constructing permanent fences around farm woodlands to protect them from grazing; establishment of sod waterways; establishment of permanent vegetative cover as protection against erosion; terracing; construction of field diversions to divert excess water to protected outlets; construction of open ditches; installation of tile drainage; construction of structures for the protection of outlets and water channels that dispose of excess water; stream-bank protection to prevent erosion or flood damage to farmland; establishing vegetative cover for winter and summer protection from erosion, establishing perennial or perennial legumes for green manure and for protection from erosion and an organic build-up practice to increase the moisture holding capacity and soil productivity of cropland and to control erosion.

For more details on the above list of practices, contact the ASC office in the Federal Building, East Tawas. Applications will be taken all through the year. Approval of these practices will depend on the availability of funds in the county allocation. Farmers will be notified if and when the practices are approved by the county committee. Assistance is available on technical phases of the drainage practices through the soil conservation service, and on the forestry practices through the forest service.
