McCready Takes Over as Prosecutor January 1

Sitting on the prosecution side in Iosco County courts starting next week will be a blind prosecuting attorney—the only person so handicapped to hold this office in the state.

Ready to take over his new office in the county building is William McCready of Tawas City, who was elected prosecutor in last November's general election.

The 35-year-old prosecutor-elect succeeds Paul Harvey, who returns to private practice. McCready scored an upset victory over the incumbent prosecutor in last August's primary election, winning the race for the Republican nomination. He was unopposed in the general election.

"I am looking forward to the challenge of this new office with great anticipation," said McCready. "In some respects, it will be a new and different experience, but I cannot visualize any difficulties as long as the work load proceeds at a natural pace."

A native of Twining in Arenac County, McCready lost his eyesight in November 1949. He received his bachelor of arts degree from Michigan State University in 1954 and graduated with an LL.B. degree from the University of Michigan in February 1958.

He and his wife, Rachel, are the parents of two children, Linda Beth, two years old, and a daughter born Tuesday of this week. They reside at 208 First Street. McCready has been a practicing attorney in Iosco County since being admitted to the state bar in March of 1959.

He and his dog, "Storm," have traveled throughout the state promoting the Leader Dog School at Rochester. He is an active member of the East Tawas Lion Club.

Two Bay City Men Admit Dec. 15 B&E of Iosco Gas Station

Breaking and entering of the Provost service station in Whittemore December 15, was solved this week when two Bay City men were apprehended by Michigan State Police.

Lawrence D. Bedell, 22, and John P. Schomaker, 20, were apprehended by Bridgeport troopers on investigation of a series of breakings and enterings in that area.

The two men have been charged with breaking and entering in the nighttime in connection with these cases and it is not anticipated that they will be returned to Iosco to face charges.

Three Auto Crashes on Slippery Roads Cause Injury to 16

Sixteen persons received injuries in three area auto accidents Monday as ice-covered, slippery roads made driving hazardous.

Most seriously injured were a National City man and his wife who were involved in a two-car crash on M-65 in Reno Township.

Taken to Tawas Hospital and then transferred to St. Mary's Hospital, Saginaw, were Richard T. and Helen P. Mielke. Both sustained arm fractures. A car driven by Aaron M. Kemp, Flint, slid sideways across the centerline into the path of the Mielke vehicle. The two Mielke children, Lynn M., 12, and Jean A., 11, received bruises in the crash.

A skidding automobile caused minor injuries to six persons as the result of a crash at the Point Lookout Road south of Tawas City Monday evening. A car driven by Walter E. Young Jr., 19, Detroit, skidded into the path of a south-bound car driven by Linda Loy Poch, 19, Bay City.

Receiving minor injuries besides the drivers were Elizabeth M. Young, mother of the driver; Edward and Judith Young, age 16 and 18. Pamela Smith, 18, passenger in the Poch car, also received minor injuries.

One person was injured Monday afternoon when a car driven by Roy Schmidt, 17, Flint, skidded out of control and hit a fence post and mail box off Monument Road. Receiving a dislocated left shoulder and treated at Tawas Hospital was Mary Tuttle, 16, Bay City. Two other Bay City youngsters, Gary Obey, 17, and Susan Schlesler, 15, escaped injury.

One other property damage accident was reported by state police.

Claims Discrimination in Hiring Practices

Two days of testimony last Tuesday and Wednesday concluded a hearing of the National Labor Relations Board, held at the Iosco County Building in Tawas City.

The NLRB heard a complaint from Frank Sutton, a member of the carpenter's union at Alpena, who charged Bateson Construction Company and Bay City Local 116 with discrimination in hiring workers.

Bateson was general contractor for construction of Capehart Housing units at Wurtsmith Air Force Base.

Attorneys for the plaintiff and defendants are to file recommendations with the NLRB.

Detroit Judge Signs Order—

Three New Plaintiffs Enter Litigation Against Bateson

Court litigation in fraud charges against Bateson Construction Company, general contractor for Capehart Housing construction at Wurtsmith Air Force Base, Oscoda, became more involved last week when three new bills of complaint were filed in circuit courts of Iosco and Wayne Counties.

New legal action against Bateson includes a bill of complaint filed by Hubbard and Associates, a Florida heating and plumbing contractor.

Its bill was similar to that filed December 2 by Catsman Company of Flint, which charged the Delaware corporation with fraudulently conspiring to obtain subcontracts for completion of housing units.

Hubbard asked Iosco Circuit Judge Allan C. Miller to issue a temporary injunction which would have stopped the prime contractor from closing its con-

tract with the United States Air Force. The request for a restraining order was denied by Judge Miller.

A show-cause hearing on the request was set by Judge Miller for Friday, December 30. He said he did not see any urgency to sign the order since Hubbard waited 21 days after Catsman to file its action.

However, a restraining order was issued Friday by Wayne County Circuit Judge Joseph A. Moynihan after a Detroit masonry subcontractor charged in a suit that Bateson used a "fraudulent plan and conspiracy" which threatened subcontractors "with imminent insolvency."

The suit charged that practices engaged in by the Bateson firm caused losses of \$120,000 by the Detroit masonry firm, operated by Alex and Richard Boratynski and Richard Garvet.

Bateson also was accused in the

suit of withholding \$54,000 in state and federal taxes on behalf of the masonry firm, but never paying the taxes to the government.

The Bateson firm, which has its business offices at Dallas, Texas, posted a one-million-dollar surety bond in Iosco County Circuit Court December 14, which permitted the company to move its equipment and close its government contracts at Wurtsmith. The Wayne County Circuit Court action, however, prevents the firm from closing out at Oscoda.

Judge Miller said Monday morning that a fourth firm had entered into the litigation against Bateson.

Pleads Guilty to Negligent Homicide

Robert R. Thompson, 29, of Davison entered a plea of guilty to charges of negligent homicide when arraigned Friday in Iosco County Circuit Court.

Originally, Thompson was charged with manslaughter following a truck-cab crash October 19 in which an Oscoda businessman and an airman were killed.

Thompson was released after posting a \$2,000 bond. Circuit Judge Allan C. Miller awaits a report from the probation department before passing sentence.

The Davison man was driver of a pick-up truck which collided head-on with an Oscoda taxi-cab on M-171 near Wurtsmith Air Force Base.

Killed in the crash were Ellis Merle Barber, 41, owner of the Oscoda Cab Company, and Al Williams Agamey, 30, of Wurtsmith, a passenger in the cab.

Investigating officers said that Thompson's south-bound truck crossed the centerline and hit Barber's north-bound taxi.

'Agriculture in an Uneasy World' is Farm Week Theme

By MARVIN DAVENPORT County Extension Director A Michigan State University Farmers' Week forum on "Agriculture in an Uneasy World" will bring together on Michigan State University campus five of the persons most qualified to discuss the subject. The five are the present and four former secretaries of agriculture whose combined length of service in that office stretches from 1933 to the present. They are Henry A. Wallace, Claude R. Wickard, Clinton P. Anderson, Charles F. Brannan and Ezra Taft Benson. All have accepted invitations to appear together Wednesday afternoon, February 1, in a non-political discussion on the role of agriculture today. Michigan State University President John A. Hannah will moderate the forum. The event will highlight the annual mid-winter Farmers' Week at Michigan State University which runs from January 30 to February 3. Wallace and Wickard served in the administration of President Roosevelt, Anderson and Brannan in the administration of President Truman and Benson in the administration of President Eisenhower. The five make up one-third of 15 persons who have served as secretary of agriculture since the agricultural department commissioner became a member of the president's cabinet in 1889. The department was created by act of congress in 1862. Anderson, who is a senator from New Mexico, and Benson, current secretary, hold public office. Benson will return to private life after President Eisenhower's term expires in January. All have agriculture-related backgrounds. Wallace was associate editor and later editor of Wallace's Farmer. After a merger of Wallace's Farmer and Iowa Home-land came secretary of agriculture. He left that position in 1940 when he became vice president of the United States. His home now is the Farvue Farms, South Salem, New York. Wickard, who was born on a farm in Carroll County, Indiana, held several positions in the agricultural adjustment administration before becoming under secretary of agriculture and later secretary in 1940. He held the position until 1945. His home is now the Fairacre Farms, Incorporated, Camden, Indiana. Anderson held several positions in relief administrations before becoming a three-term member of the house of representatives from New Mexico. He went from the house to secretary of agriculture in 1945 and from that position to the senate in 1948. Brannan, a Denver, Colorado, attorney, was associated with several USDA organizations before becoming assistant secretary of agriculture in 1944. He became secretary in 1948 and held that position until 1953. Benson was a farm operator for seven years and a member of the Idaho Cooperative Extension

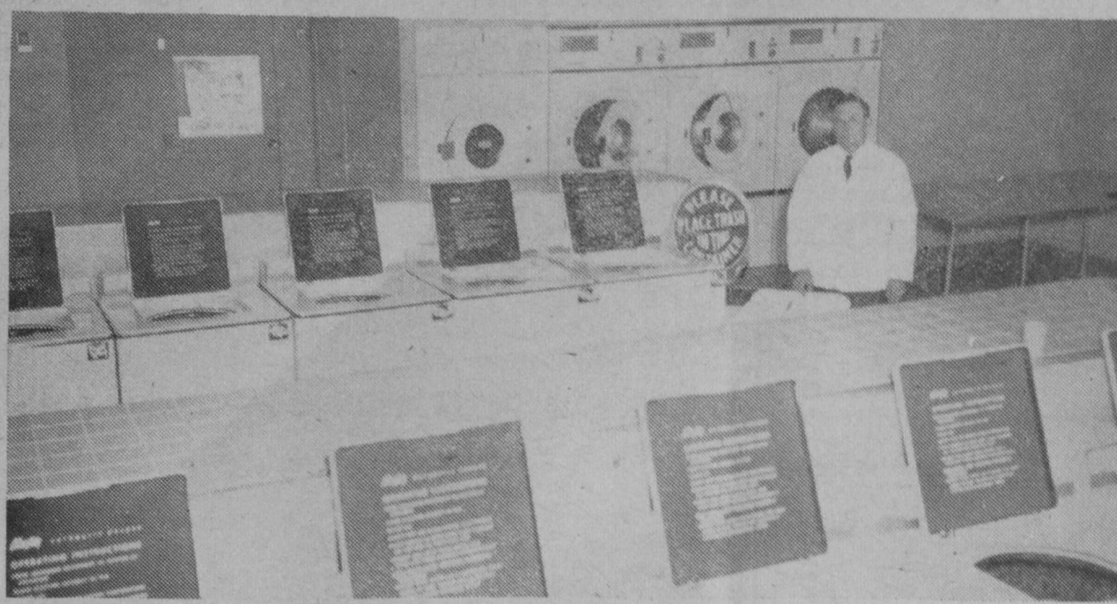

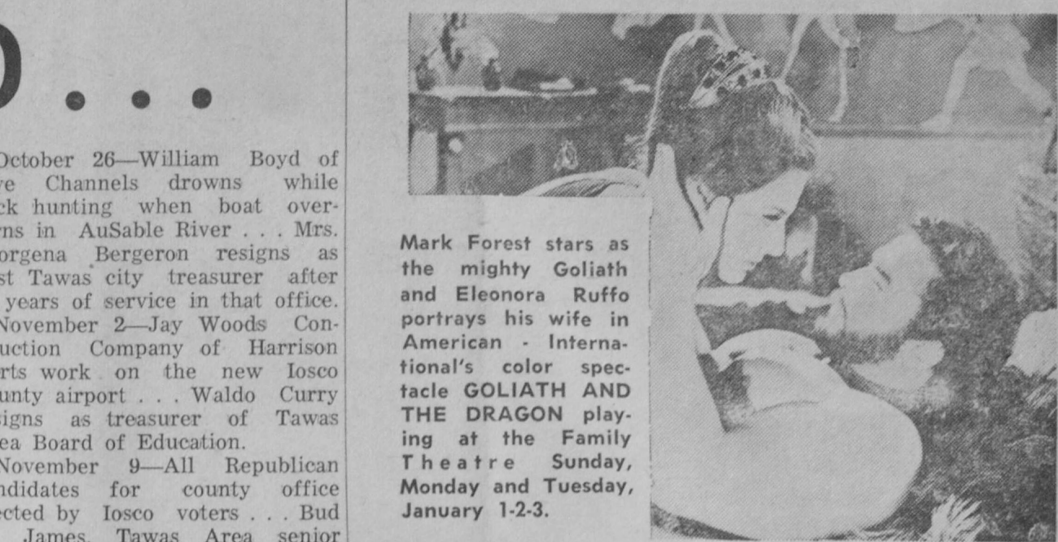

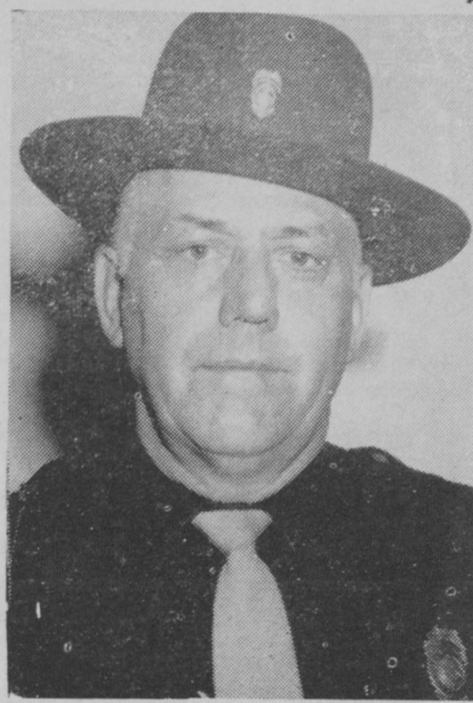

and the experience of time indicates that the judge should learn to resist the temptation to interrupt."

According to Miller, the obligations of the bench in the way of civilian duties and public relations for the bench and bar were about as he anticipated.

"The allied and difficult situations of the bench, however, are in handling the persons who fail to understand why they cannot just call or visit the judge and get the answer."

"This is understandable. It violates, however, basic tenets of justice to take information from one side without the other being present. And, probably even more important, until both sides have formally urged their viewpoint in open court, even the judge is not in a position to give worthwhile and considered opinion."

Some of the changes which he plans to inaugurate in court procedure here next year includes starting the terms of court on Mondays instead of Tuesdays and move the September term up one week.

Miller said that the Tuesday opening of court had been the practice for years and it is still the rule in many circuits. It was originally intended to allow time for the judge to travel to his place of holding court, either by horse and buggy or railway.

He said that with today's faster means of transportation, the extra day of travel was unnecessary and moving up the day for opening court would mean one extra day in the week for court cases.

Miller said that the new court rules, now in the process of drafting, would probably include supervisory power the judge has over justice courts. This step is being taken on petition of state and county bar associations.

"In effect, this supervisory power will be in an educational or orientation manner when a new

JP takes office," said Miller. He said that this action was following the spirit of a recent supreme court ruling. "We are going to exercise this power in a constructive method," he said.

Ethics of office will be explained to new JPs at the first school of instruction in April.

Judge Miller said that he had reviewed many of the old pleadings in circuit court records here . . . "just to get the feel of things."

One of his pet projects now, co-sponsored by the bar association of this circuit, is to prepare and perpetuate the opinions handed down in court by Judge Dehnke.

Miss Bessie Brown, circuit court stenographer, is now in the process of typing copies of these opinions. They are to be bound and a copy will be placed in the three law libraries of the circuit.

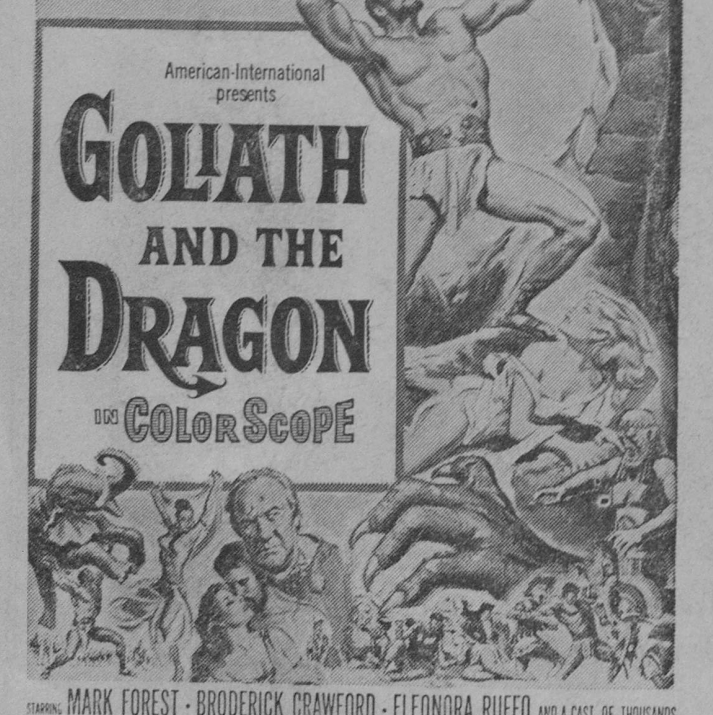

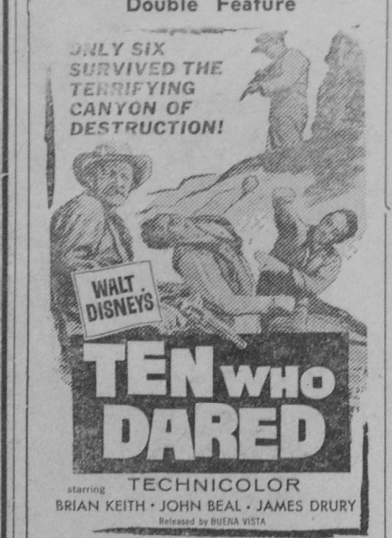
