NEM Baseball League Set for '60 Season Openers

Little Northeastern Michigan Baseball League has gone "big league," at least in one instance.

This year, the National League starts its season one week in advance of the American major league. Now the National Division of the Northeastern Michigan

First Games—

The league schedule, as announced Tuesday by President Fred Jones, lists the following games for Sunday, May 15: West Branch at Tawas City; East Tawas at Prescott; Skidway Lake at Melita, and Hale, open.

League jumps off to a week's advantage over its American cousins by announcing its opening date as May 15 while the American will not start operations until May 22. It all came about this way. Because of seven clubs in the National, it was decided that the schedules could be better balanced to start off the National playing a week ahead of the American, then the seasons would end nearer to the same date and would make the matter of playoffs for the championship more equalized.

The league this year will consist of 13 clubs, East Tawas, West Branch, Hale, Tawas City, Melita, Skidway Lake (new this year) and Prescott in the National; Sterling, Worth, Rhodes, Beaverton, White Star and Crump in the American. The White Star team will play its games on the fairgrounds diamond in Gladwin.

The directors decided to have a "round robin" series for 1960. The first and third place teams of each division will play each other and the second and fourth place teams will tangle. The winners of these sets will play each other to decide the team to go to the amateur series at Battle Creek. Following the Battle Creek games, the winners of the championship in each division will play a series of the best two out of three games to decide the league championship.

The 1960 all-star game will be played July 15 at Tawas City. June 30 was selected as the date to choose the players for the all-star game. The meeting will be held in Standish. Fred Jones and F. E. Perlberg were named as a committee to draw up the schedules for the 1960 season.

Lyle A. Berry Signs Teaching Contract

Lyle A. Berry, 25, who graduates from Central Michigan University this June, has signed a teaching contract with Tawas Area High School for the 1960-61 school year, it was announced Monday by Principal Ernest Jordan.

Berry, a native of Grand Rapids, will teach junior high general science and is to join the athletic department as assistant junior varsity football coach. A veteran of United States Marine Corps service, Berry is married and the father of one child.

After starting in four high school sports in his home town, Berry attended Grand Rapids Junior College where he participated in baseball, football, basketball, crosscountry and track. He took part once in the national junior college championship football game in Los Angeles, California.

Mr. Jordan also announced that Donald Wallace, who has been a member of the junior high faculty for the past two years, has signed his teaching contract for the 1960-61 school year. He will also be junior high principal, a new position just created. Wallace had coached tennis and junior high basketball during the past year.

The high school principal said that three vacancies on the high school faculty remained to be filled. Yet to be hired are an English teacher and two social science instructors.

Mayor Exchange Feature of Michigan Week Observance

The people of Michigan will blow their own horn louder than ever during the 1960 Michigan Week observance, which opens Sunday, May 15.

Locally, this seventh annual state celebration will be observed principally with mayors' exchange day Monday, May 16, in the Tawas. Whittemore will not participate this year.

In Tawas City, the businessmen's association and city council will be host to Beulah Village President Philip Ehman and one of his council members. In the exchange, Mayor George Tuttle will go to the Western Michigan community.

Mayor R. J. Alexander of Oak Park will be guest at East Tawas, exchanging with Mayor Elmer Werth. Mayor Alexander and his wife will arrive Sunday, as will Mr. Ehman.

The two Beulah civic officials will be guests of honor at the noon luncheon of Tawas City Businessmen's Association at the Vic and Zel Restaurant. Monday morning's program will include a tour of area industries, a visit to the county building, jail, the new Tawas City disposal plant, Tawas Area High School and other city installations.

Mayor Alexander will tour industries and various public buildings Monday morning and will be guest of honor at a noon luncheon to be held at the Holland Hotel.

Meanwhile, Mrs. Alexander will tour the area and will be entertained at a noon luncheon to be held at the Harbor Lights Restaurant. Accompanying her will be wives of councilmen and businessmen.

Featuring the day's program in both communities will be a tour of Wurtsmith Air Force Base by the visiting mayors, councilmen and businessmen of the Tawasess. Brig. Gen. Harold Humfeld, 40th Air Division commander, will be host.

Mayor Alexander and his wife will be guests at a dinner to be held Monday evening at the Holland Hotel. The visiting mayor will also preside over a meeting of the East Tawas Council which will be held at 7:30 o'clock.

A dinner has been tentatively scheduled at the Barnes Hotel for Mr. Ehman and members of the Tawas City Council, key city personnel and their wives. The regular Monday night council meeting has been postponed until Tuesday night.

Whittemore's observance of mayors' exchange day had to be canceled, although plans had been made by the council. The city with which Whittemore was to exchange mayors was unable to participate.

Sheriff's Dept. Nabs Trio Shortly After Burglary

Three men who burglarized a Hale restaurant early Monday morning were apprehended in a matter of only a few hours by the Iosco County Sheriff's Department.

Held at Iosco County Jail under \$1,000 bond are Allan Boughner, 23; James Rehil, 19, and Lee Howard, 19, all of rural route Hale.

The trio entered pleas of guilty to breaking and entering in the nighttime when arraigned before Justice of the Peace A. J. Goulet Monday and were bound over to circuit court. A probation detainer has also been filed against Boughner.

The men admitted breaking into the Hale Coffee Shop at 4:30 Monday morning. When Vernon Ranger, owner, opened the restaurant at 5:30 o'clock, he found that the back door had been forced open, \$25 had been taken from the cash register and a quantity of food taken.

Sheriff's Deputies Gene Balla-

ger of Tawas City and Dennis Chivria of Hale were called to investigate and an abandoned car owned by Boughner was found in a nearby parking lot. The officers became suspicious and, after checking with relatives of Boughner, learned that he was last seen on Saturday in the company of Rehil and Howard.

A description of their car was learned and an area broadcast was made by Michigan State Police at East Tawas. At 9:45 o'clock, Sheriff Ivan O'Farrell apprehended the men while they were traveling through Whittemore.

O'Farrell, who had been investigating a gas larceny complaint in Whittemore, found equipment for siphoning gasoline in their car and held them under suspicion. When the car was checked later, the three men confessed to the break-in when confronted with a quantity of cigarettes and other merchandise which was found in their car.

The men also admitted larceny of gasoline from trucks parked in Whittemore and Turner the same night.

Merchants Asked to Dramatize Advances

Merchants of Iosco County are being asked to dramatize cultural advancement during Michigan Week, May 15-21, by displaying in store windows the contrast between the things people used to wear, purchase and use with the present day product.

People who own old-fashioned articles are asked to contact merchants who sell the modern counterpart. If the history of the article is known, it should be typed on a small card to add extra interest to the window display.

Local establishments are asked, also, to display old letterheads, ledgers, pictures and other evidence of their past.

Anyone having early pictures of the main streets, of bands or teams, early fire departments, historical landmarks, etc., are urged to add them to a display at the Peoples State Bank in East Tawas. Each article should be labeled as to who is lending the item so that nothing is misplaced.

Mail Box Improvement Week is May 16-21

The post office department has designated the week of May 16 to May 21 as Mail Box Improvement Week. This improvement program will include mail boxes on mounted city routes and star routes with collection and delivery service, as well as mail boxes on rural routes.

The department wishes to encourage patrons to provide suitable mail receptacles, erected and maintained for easy and safe accessibility, presenting a neat appearance and affording protection to the mail.

Boxes that are not properly erected or not maintained in good serviceable condition retard the delivery of mail and expose it to the weather. Boxes that are no longer serviceable must be replaced.

Russia is Topic at Extension Meeting

Twelve home economics extension groups placed exhibits at the annual spring achievement program May 4 at the Masonic Temple. These exhibits revealed a wide range of study lessons and activities grouped in three major efforts: To develop managerial ability and homemaking skills, encourage community service and provide opportunity for self-expression.

In the first grouping were heart attacks, casserole cookery, houseplants, better breakfasts, property rights, cake decorating and hooked rugs.

Group two was home preparedness through Civil Defense and group three included candlemaking, glass etching, Swedish embroidery, textile painting, basket weaving, aluminum etching, decorative stars, ceramics and leathercraft. Some of these have been homemakers camp projects, others have been possible because of spe-

'Club' Investigation Leads to Arrests

State police of West Branch said Saturday that they had taken 13 persons into custody for allegedly holding orgies in Ogemaw County.

Involved were five girls, 14 to 16 years of age, and three 16-year-old boys. Criminal charges have been filed against five older members of the "club." More arrests are possible.

Most of the minor members of the gang are students at Whittemore-Prescott Area School, said the police.

The 13 were taken into custody about two weeks ago. Meetings of the club were held on the average of three or four times a week in vacant summer homes and cabins in southeast Ogemaw County.

Troopers were led to the gang while investigating vandalism at summer homes in the Skidway Lake area. A link between the gang and the vandalism is being sought. Damage to six cabins and summer homes in the area has been placed at more than \$2,000.

Charged with statutory rape and taking indecent liberties are Roderic Patrick Olson, 18; his brother, Carl, 17; Jack David Brown, 22; Eugene Crozier, 22; and George Roy Yennior, 24. Brown lives in rural West Branch. All the others live in the Skidway Lake area. All are free under \$500 bonds and all except Yennior demanded justice court examination.

The minors rounded up in the case have been released to the custody of their parents pending probate court hearings. Ogemaw County Prosecutor Randall B. Clemence said he had not decided whether to ask juvenile court waivers so the minors could be charged as adults.

New State Law—

Rollin Warns New Pupils Need 'Shots'

Iosco County parents, who this month will enroll their children in school for the first time, were reminded of a new state law requiring the youngsters to be immunized against five diseases.

The diseases are smallpox, diphtheria, pertussis (whooping cough), tetanus (lockjaw) and poliomyelitis, explained Russell A. Rollin, county superintendent of schools.

Mr. Rollin also explained the exact letter of the new law today.

All children enrolling in public, private or parochial schools in Michigan for the first time must submit a statement signed by a physician indicating that they have been immunized against the diseases.

Alternatives, under the new law, include: Submitting a statement signed by a parent or guardian to the effect that the child has not been immunized because of religious convictions or any other objection to the immunization; or a request signed by a parent or guardian that the local health department give the needed protective injections.

The new law was signed into effect by Governor Williams on April 8.

Local parents become immediately involved in the aspects of the new law since registration for kindergarten youngsters takes place this month in public schools here.







Outdoors WITH EMERY

Fishing on the East Branch of the AuGres River last Wednesday with George Hoerner and Jack Phillips of Saginaw, we caught five "steelhead" trout, the largest about 16 inches in length. We checked these trout and there were no signs visible that they had been the victims of the lamprey eels.

Anyone catching a "steelhead" with a jaw tag is urged to report the information to the fisheries biologist, state fish hatchery, Marquette. The information needed to study the growth and movement is the tag number, date caught, location, length and sex of the fish.

At a special public hearing May 12 at Higgins Lake conservation school, a proposed change in commercial fishing regulations to permit the use of trawls in Michigan waters of the Great Lakes will be discussed. Any commercial operators or interested parties unable to attend should forward their views to the Higgins Lake School. This regulatory change, as it is proposed, would authorize the conservation department to issue permits for the use of trawls by commercial fishermen to take herring, chubs, alewife, smelt or any other fish species the department may designate.

Weather-wise it was a cold, rainy week-end with the only real signs of spring being several clumps of wild violets in bloom and the wild fern shoots sticking their heads through the ground.

J. M. Roberts, the AP news analyst, in his column recently described the massive distribution of "Ideology and Co-Existence" as "One of the most intense non-governmental ideological campaigns ever attempted."

"Ideology and Co-Existence" has been likened to the famous revolutionary pamphlets of Thomas Paine in its power to rally patriotic men to unite and fight for their convictions.

"Ideology and Co-Existence" faces America with the choice expressed in the words of William Penn, "Men must choose to be governed by God or they condemn themselves to be ruled by tyrants."

Admiral William H. Standley, former United States ambassador to Moscow and chief of naval operations, echoes this challenge when he says, "Moral Re-Armament is a continuation of the American Revolution on a world scale. The choice for America is Moral Re-Armament or communism."
