

For years, many high school in dustrial arts classes have turned out an endless assortment of end tables, foot stools, boot-jacks and other small articles-the type of bricabrac that usually ends on the trash heap, once it is taken home. Not so this year at Alcona Community Schools, located five miles west of Harrisville.
