The Dow Chemical, a 10,000-ton ore carrier, will close United States Gypsum Company's 1960 shipping season when it loads next Tuesday at Alabaster. Maynard VanOrnum, works

manager for USG at Alabaster, said Monday morning that 1960 was a "normal" season for gypsum production. He said that although there were fewer ships loaded out at the off-shore bin, the carriers handled total tonnage equivalent to recent years.

Higher water in the Great Lakes this year made this possiole, said VanOrnum, through loading carriers to capacity. Next Tuesday's ship, bound for Detroit, will be loaded at winter draft, however. Some 9.000 tons of gypsum ore will be shipped.
