# **What is The Reformation?**

Many men were associated with the Protestant Reformation - none, however, is more identified with this great movement than Martin Luther. Martin Luther was a Roman Catholic priest, overseer of 10 monasteries of the Augustian order and the leading professor at Wittenberg Univeryears of study that the church had grad-

ually changed into something different than it was in the beginning. Luther's open "protest" came when other monks began to sell papers for the forgiveness of all sins in order to raise money for the church. On October 31, 1517, he called for a debate and reform movement within his church: This began the Reformation.

These are the principles that Luther set forth from the Bible, and which Lutherans of today give thanks for:

THE OPEN BIBLE: All who are hungry for God's Word may hold this book in their hands.

CHRIST ALONE is the Head of the Church in that men on earth may at times err, and men may pray directly to God without any mediators.

SAVED BY FAITH ALONE: Forgiveness of sins and salvation comes not through payments, pilgrimages, recitations nor the adoration of saints or relics, but as the Bible teaches: "For by grace are ye saved through faith, and that not of yourselves; it is a gift of God; not of works, lest any man should boast." Ephesians 2:8-9.

THE RIGHT OF PRIVATE JUDGMENT: Every man is free in his own conscience to decide from the Bible what is right or wrong, and no organization may dictate to him what he shall believe or do; he is free to read any books, think any thoughts on the basis of his own conscience and will be judged by God.

THE COMPLETE SACRAMENT: Both the Body (bread) and the Blood (wine) are to be received in the Holy Communion.

SEPARATION OF CHURCH AND STATE: No church shall prescribe the social and political orders, but the reasoned judgments of all citizens shall elect officials who will genuinely serve the public good and guarantee the rights of differing religious views.







The present building is over 85 years old and considered a bad fire hazard. If a fire should start in this building, it could easily spread and cause consid erable damage in our business area. This could also mean the loss of records which have been kept since the city was organized

This building is like a barn the way the cold wind blows through and the cracks in the windows and doors are stuffed with rags and covered with building paper This certainly does not look good to our people coming in to vote to see the members of the elec tion board wearing overcoats and the women wrapped in blankets to keep warm.

Our city is growing and it seems to me we should have one central place where all city business can be transacted and where all records would be safe. Looking at the new modern

buildings now in our area, the Federal Building, Tawas Area School, county building, hospital, etc., our city hall is a disgrace to the area.

Regardless of whether you vote Republican or Democratic on election day-be sure you vote "yes" on the city hall proposal. Then, you will have done your duty for the city pride in both the present and coming genera-
