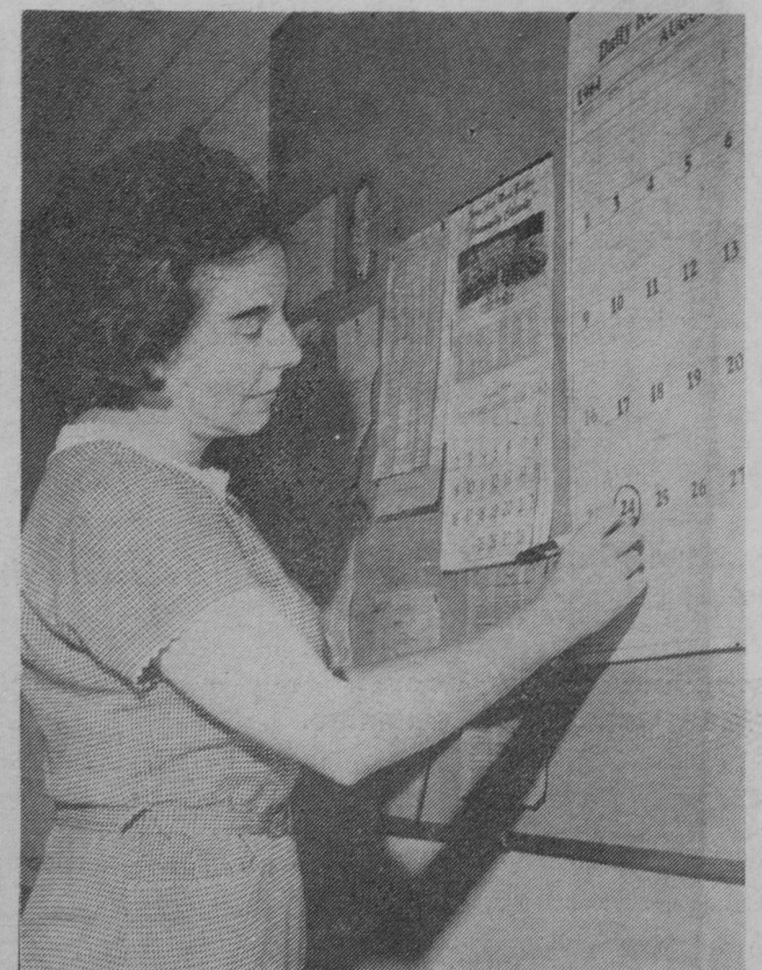

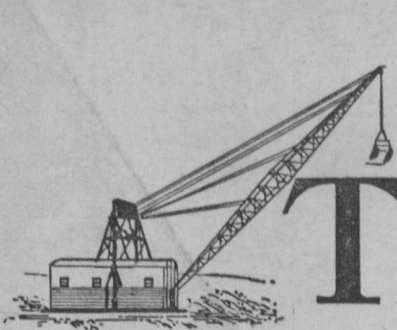
Former Tawas Man Candidate for Senate

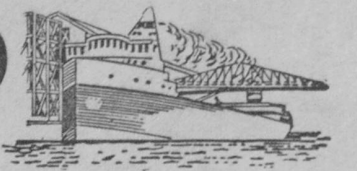

Tourist Festival Starts Thursday

Official program for the second annual Michigan Tourist Festival starts Thursday in the Tawas. A full schedule of events is planned through Sunday.

Deluxe Amusement Rides Carnival rolled into the Tawas Monday and set up exciting rides at Immaculate Heart of Mary School ground on US-23.

Retail merchants of the area displaying a Michigan Tourist Festival poster are offering special tickets to youngsters which, when presented at the carnival, entitle the bearer to a reduced admission price on rides.

Tawas City Park will be the site

of a sports equipment display. Many local manufacturers of sports products, including camp trailers, boats, camping equipment and other products, will be displaying goods for inspection. The festival committee has also invited many manufacturers from the entire state to set up displays at the park.

The festival gets off to a rocking start Thursday night with a street dance on the first block of Newman Street. The street will be closed off starting at 9 o'clock.

Alcona Dam Repair Set for September

Repair work at Consumers Power Company's Alcona hydro plant on the AuSable River will require lowering the plant pond level for a brief period during September.

Paul F. Ingell, regional superintendent for Consumers Power, said the pond level will be lowered a total of four feet at the rate of one foot per day beginning the evening of September 6. This will permit repairs to the concrete walls on the upstream side of the dam.

The pond level will be raised gradually after September 18. By September 23, it will be back to normal.

Pond level will be restored well ahead of the annual AuSable Valley canoe race scheduled for October 3-4.

Examinations Slated for ET Gas Installers

Examinations are to be held Thursday and Friday nights for licensing gas appliance installers at East Tawas. Meetings are to be held at the city hall starting at 8 o'clock.

These examinations are in accordance with the city's new gas ordinance, adopted at its meeting two weeks ago.

At Monday night's meeting of the city council it was announced that applications would be received at the same time for city inspectors to enforce provisions of the new ordinance.

In other business, the council turned a request of the Michigan Waterways Commission over to the parks, waterways and docks committee for further study. The state waterways committee asked that the city deed 10 feet of shoreline from the dock east to the end of the park. It also asked that land on which the dock office is located be deeded to the waterways commission.

The state park is to revert back to the City of East Tawas on January 1, 1965, following recent action of the Michigan Department of Conservation. The state is developing its new park on Tawas Point.

It was the consensus of councilmen that the shoreline in question be retained until a complete study is made for an over-all plan for city park development. It was thought that a boat ramp might be installed there. The council believed that transfer of land on which the waterways commission dock is located could be approved.

Members of the parks, waterways and dock committee which will study the request are Chairman Carl Babcock, W. D. Nunn, Ralph White, Harold Gould and Councilman Edward Lixey.

Peter A. Lichtfusz, representing the Iosco Sportsmen's Club, was present and requested that commercial use of a boat ramp behind the city disposal plant be stopped. Construction of the boat ramp had been a joint project of the city and sportsmen's club.

Lichtfusz said that out-of-town commercial fishermen were using the ramp for unloading of fish, thus interfering with launching of pleasure boats, for which purpose it was intended.

The council stated that permission to use the ramp for commercial purposes had not been granted.

Alert Dock Master Saved Life of Tot; Praised by SP

Quick action by a Waterways Commission Dock attendant with saving the life of a two-year-old Detroit boy, who fell into about 10 feet of water off shore from the state park.

Michigan State Police at East Tawas said that little Christopher Hohl probably would not be living today had it not been for the immediate reaction to an emergency by Brent Babcock, 19, waterways commission dock master.

Christopher is the son of Mr. and Mrs. Thomas A. Hohl, who were spending several days vacationing at the state park. He was whisked away after a near heartbreaking experience.

Shortly after 9:00 a. m. Thursday, the Hohl's seven-year-old son, Joseph, told his father he was taking Christopher for a walk. After they left, Mr. Hohl suddenly realized that Joseph and Christopher, who was being pushed in a stroller, might be headed for the dock.

He ran after them and found a crowd of people standing around Joseph, who cried that the baby and stroller had rolled off the dock.

The accident occurred on the east end of the dock at an incline which connects a series of boat wells. Joseph said he let go of the handle and the stroller coasted down the ramp and Christopher plunged into the water.

A witness to the accident ran to shore to notify Babcock, who was working near the harbor master's office. Babcock had to run approximately 1,400 feet to reach the scene. On arrival, he found a large crowd of people had gathered but only one person had made an attempt to rescue the child. A spectator had dived into the water fully clothed, but could not reach bottom.

Babcock peeled off his clothes, dived into the water and, on the first try, found Christopher lying face down on the bottom. The child was turning blue and not breathing when Babcock handed him to persons on the dock. After climbing up the piling, Babcock found the child lying on the dock and no attempt being made at resuscitation. The child's distraught father could offer no assistance, nor was there help from the other spectators.

Babcock forced about a pint of water from the baby's mouth and then applied mouth-to-mouth respiration. The child had apparently been in the water for about five minutes, nearing the time limit of suffocation before death. For a while, Babcock's efforts seemed to be useless, but the child finally started to breathe and his crying could be heard as far away as the state park. He was whisked by ambulance to Tawas Hospital.

Christopher was released Friday morning with apparently no ill effects from his submersion. Before leaving for home, the family bid a tearful goodbye to the young dock attendant whose actions averted a tragedy for them.

New Zoning Ordinance Reviewed With Council

The first of several meetings to review provisions of Tawas City's new zoning ordinance was held Monday night by the city council and planning commission.

Conducting the general discussion was Charles Leman of Villcan-Leman and Associates, representing the city's planning consultant firm. Representing the planning commission was Chairman Hugo Keiser.

Leman said that the new ordinance was set up basically the same as the old one adopted in 1949. However, the new document is much more comprehensive in that it fully defines words used, provides for seven zoning districts instead of three, spells out how districts may be used and has a complete schedule of regulations.

Long range planning for the community can only be carried out through a proper zoning ordinance, said Leman. "The answers to questions which may arise are contained in the ordinance, rather than to leave it to someone's guess."

The planner emphasized that there was nothing restrictive in the new ordinance in regard to present land or building uses.

"Under zoning," he said, "we are trying to get the town straightened out over the long haul. The existing pattern of uses pretty well dictates future growth, but a good zoning ordinance is needed if there is ever to be any renewal activity in the area."

General provisions of the ordinance were discussed briefly. Councilmen had the opportunity to study the document for about a month and a number of points were raised in regard to provisions. Several changes were suggested by councilmen and Mayor George Tuttle.

The new ordinance provides for a five member citizen's group acting as a board of appeals. At present, the council hears all appeals on zoning. It was stressed that

there would be no conflict of activities between the board of appeals and the council. The council adopts and amends the ordinance and it was the planner's recommendation that it should not sit in judgment of its own actions.

A zoning administrator, probably the superintendent of public works, would inspect applications, issue permits to build and, when construction is completed, inspect the premises to determine if provisions of the ordinance had been followed.

It was stated that minimum requirements have been set up for residential areas. There are three

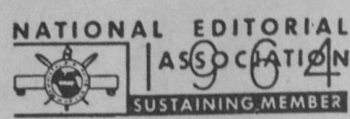

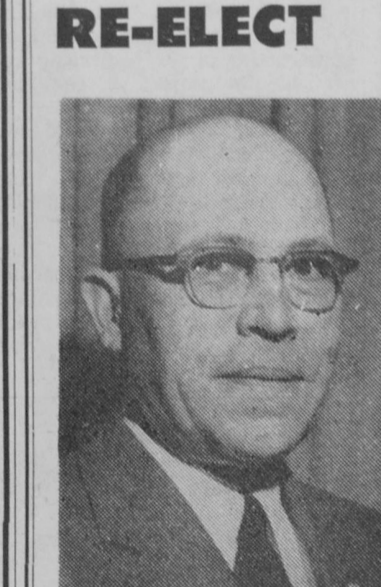

Six Indian Tribes Roamed State, Says WSU Historian



DETROIT — "Michigan Indians in the early 17th Century spent less time in war pursuits than in agriculture and hunting, enjoying peace among themselves and relative isolation from the Iroquois of the Eastern seaboard and the Sioux of the West," says Prof. Philip P. Mason, Wayne State University historian and archivist.

Most of the major towns and cities in Michigan today were once the sites of thriving Indian villages, many of them only semi-permanent because of the Indian's awareness of the need for avoiding soil and game depletion. White settlers, like the Indians before them, also chose water sites because of the transportation and other advantages they offered.

In the Upper Peninsula, Sault Ste. Marie, St. Ignace, Escanaba, L'Anse, and Munising were the sites of major Indian villages; Lower Peninsula sites included Mackinaw City, Petoskey, Traverse City, Grand Rapids, Lansing, Ionia, Saginaw, Bay City, Detroit, Midland, Flint, Kalamazoo, Niles, Battle Creek, Monroe, Jackson and Muskegon.

Today there are four Indian reservations in Michigan. The largest one is in the L'Anse area of Baraga County, in the Upper Peninsula. This has a population of 1,300. The other Upper Peninsula reservations are the Hamanville Indian Community in Menominee County with 140 persons and the Bay Mills Community in Chippewa County with 300.

The one reservation in the Lower Peninsula is in Isabella County. This is the residence of the Saginaw Chippewa Tribe, numbering about 400 persons.

Six main tribes combed Michigan's forests for food during this Century and also raised corn, squash, rice and tobacco near their semi-permanent settlements scattered about the State. The tribes were the Chippewas, sometimes called the Ojibwas, divided between the Upper and Lower Peninsulas; the Ottawas in the northern half of the Lower Peninsula; the Potawatomis in the southern part of the Lower Peninsula; the Miamis in the southwestern section of the State; the Wyandots, often called Hurons, in the Detroit area; and the Menominees, or "Wild Rice People," in the county which now bears their name.

The peaceful disposition of these tribes made it possible for them to intermingle without conflict so that there were no distinct tribal boundaries.

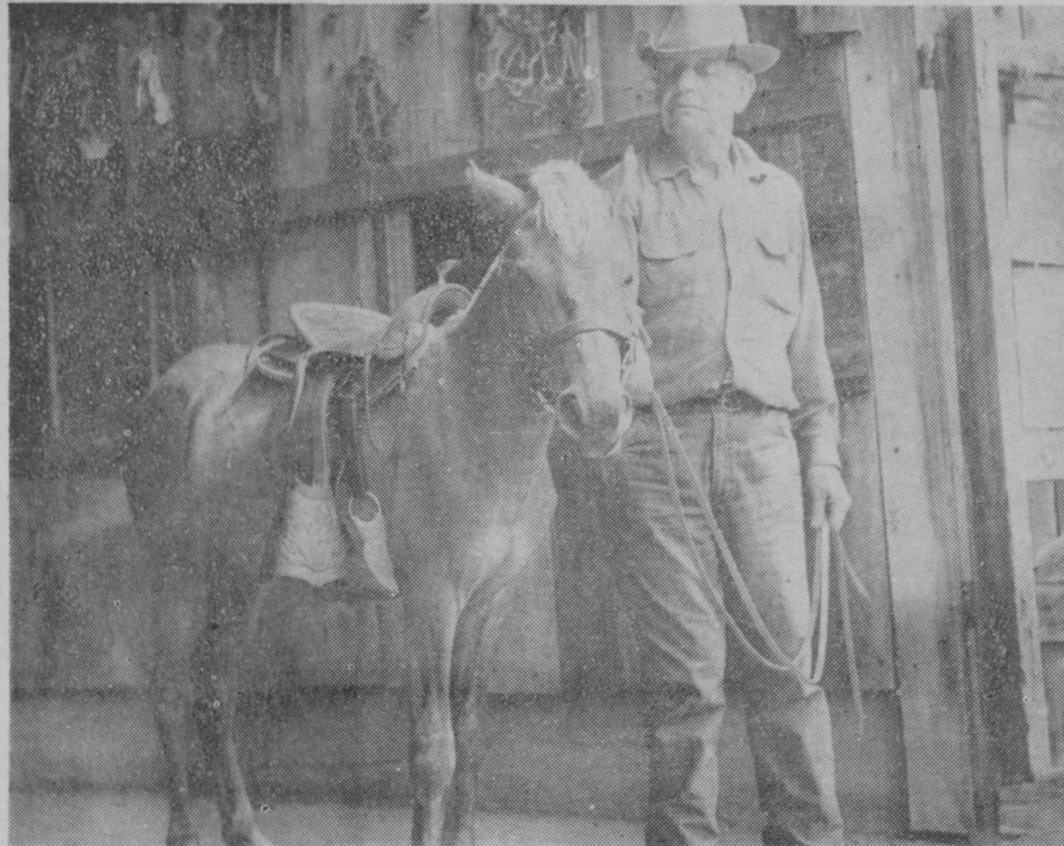

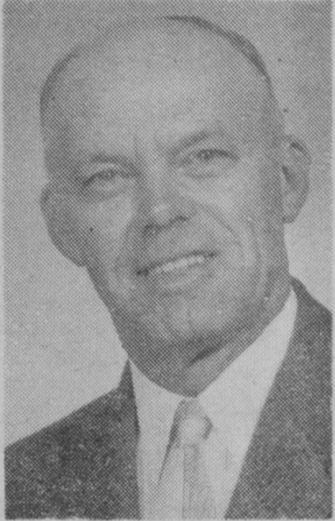

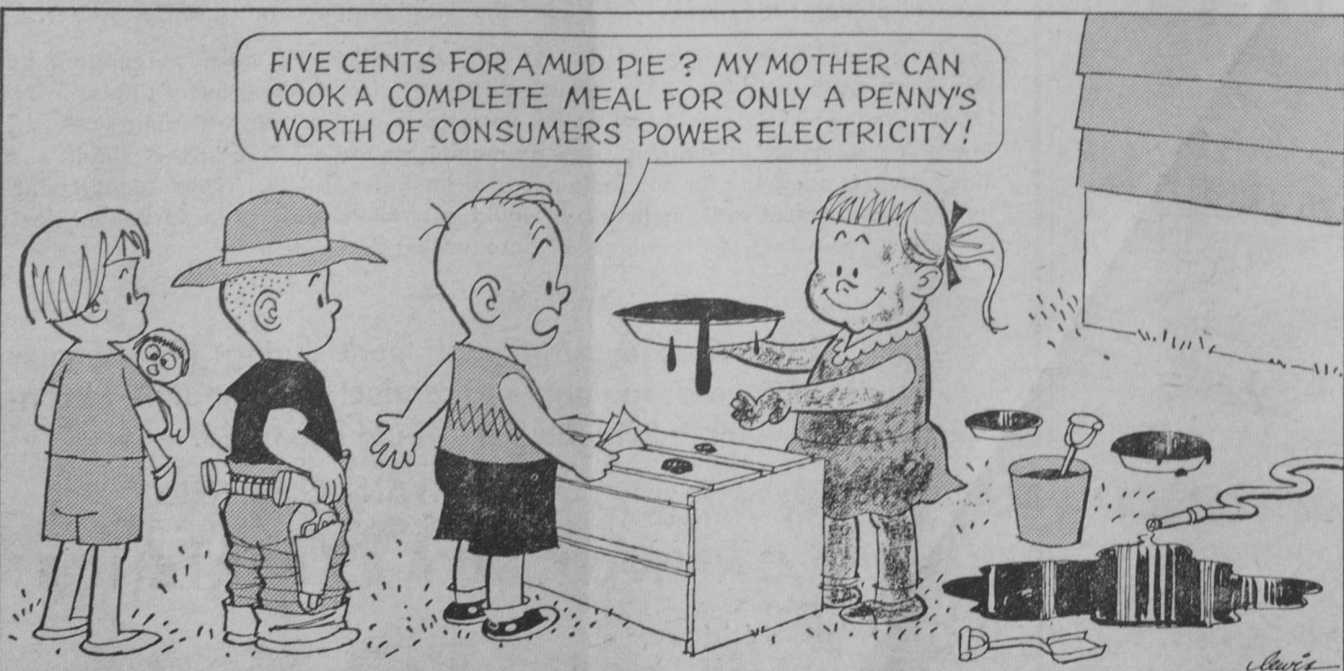

I wish to thank the many who signed my petitions for the Appeals Court and know there are many others who would have welcomed the opportunity.

As I explained the day I announced, I represent the best people in the best area of the State, but it is high time someone protested judicial encroachments upon the other branches of government. As D. Hale Brake stated last week "our government has become an oligarchy." A government by a small group. Basic principles which endured for 200 years, such as three equal branches of government and a Senate based on the Federal pattern, suddenly are wrong!

A flagrant invasion of the legislative sphere.

In protest, I tossed in my hat. I intend to make it a vigorous protest. My campaign has already taken me into 39 of the 66 counties. I have attended over a dozen county fairs, have been in hundreds of shops and on many more doorsteps.

I request your support September 1 on the non-partisan ballot to demonstrate the objections of all thinking people to further judicial encroachments.

Beef Cattle and Forage Crop Practices Meet Set

Latest beef cattle and forage crop production practices will be featured in an all-day program at the Michigan State University Experiment Station Farm at Lake City Wednesday, August 26.

Livestock farmers will have a chance to see several new species of plants which show promise for forage crop production. Plots will also be viewed showing results of improved varieties of birdsfoot trefoil, alfalfa, corn, sunflowers, lupines and sudan grass crosses.

The 100-head commercial beef cow herd kept at the farm is being used in a research project to evaluate the effectiveness of selection for tenderness and leanness in beef cattle. It also demonstrates the adaptability of the commercial beef cow and calf program in Northern Michigan.

Field day visitors will also have a chance to view new flail-type

mowers and crop windrowers. They will also hear from Robert DeBoer, farm foreman, on a simplified system of hay making used at the farm. Other farm tour stops will include pasture renovation, seeding methods and farm ponds. Tours of the experimental plots will begin at 9:30 a. m. A noon lunch will be available.

Leaves for Pacific Duty Aboard Missile Cruiser

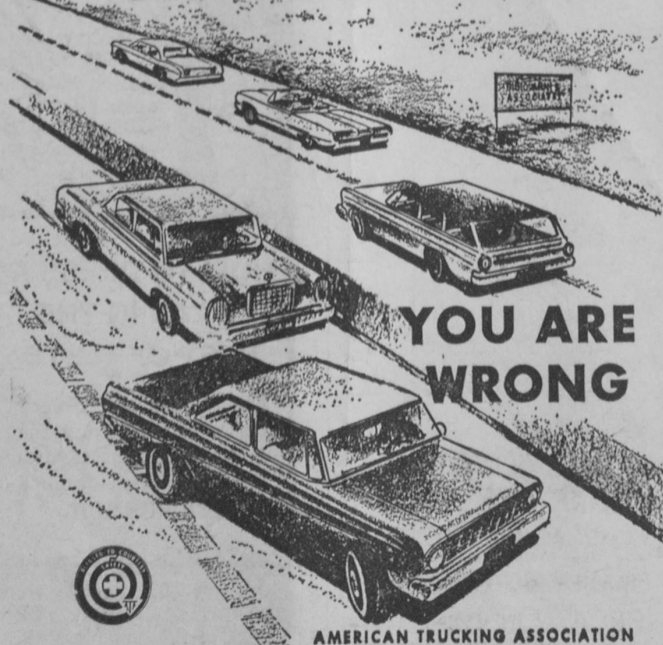

Fully equipped for battle, the Columbus carries a complement of 1,700 men. Conversion from a heavy cruiser brought aboard the "Talos" and "Tartar" missiles, replacing her main gun mounts. These surface-to-air missiles, along with antisubmarine warfare gear and new, improved sonar equipment for submarine detection, complete her present armament. Allowances were made during conversion for the placement of a "Polaris" launching system capable of firing eight missiles.

During her tour with the seventh fleet, Columbus will operate in the vicinity of Japan, Taiwan and the Philippine Islands. She is homeported in San Diego, California.

Some of the Many Duties and Responsibilities of Your Sheriff

The office of sheriff appears in English jurisprudence about A. D. 1000 and every English speaking nation has such an office. The sheriff is the only police officer ELECTED BY AND RESPONSIBLE DIRECTLY TO THE PEOPLE of the county.

Where some law enforcing agencies have only criminal jurisdiction the sheriff's responsibility goes much further and includes CIVIL CASES as well. Also his jurisdiction covers the entire county.

He must enforce all laws enacted for protection of lives, persons, property, health and morals of the people. It is his duty to act as conservator of peace within the county, using such forces as may be necessary and to prevent breaches of the peace, suppress affrays and unlawful assemblies. It is also his right and duty to arrest all persons who oppose execution of process.

He is an officer of the Circuit Court, aids in drawing prospective jurors, and by deputies acting as court officers, is responsible for juries during court trials and while they are deliberating on cases.

The sheriff is responsible for the confinement, safe-keeping and feeding of all jail inmates, must present them in court and convey them to any state institution to which they may have been committed by the court.

Through him or his deputies the office makes investigations for the prosecutor, the several courts and coroners and serves writs,

such as warrants, summonses, attachments, executions, replevins, garnishments, capias, habeas corpus, body attachments, subpoenas, injunctions, peace bonds, notices to quit, evictions, levies on real estate and personal property, and other documents in connection with cases, both criminal and civil, to be heard in the following courts: Circuit, Municipal, Justice, Probate, Juvenile, Circuit Court Commissioners.

He and a coroner visit the scene of and investigate violent and mysterious deaths, and he assists the coroner and prosecutor whenever an inquest is ordered to determine the cause of death, if possible.

He is a member of the County Concealed Weapons Licensing Board and attends numerous safety and traffic meetings and other conventions, both state and local, having to do with matters pertaining to public safety and enforcement of all laws.

From his office many reports have to be made and sent to the State Corrections Commission, the State Highway Department, the FBI, the National Safety Council and the county Board of Supervisors.

To avoid malfeasance he himself is limited by law and cannot always do or accomplish the things he is very often asked to do. In the discharge of his legal duties, however, the sheriff is expected to use all the means provided by law to accomplish such ends.

★ ★ ★

The Iosco Sheriff's Department is staffed by two full-time deputies and a woman office deputy, plus the sheriff, Sheriff Ivan O'Farrell and the Iosco Sheriff's Department have been cited several times for operating a competent and efficient organization and have received a high rating each year from the Michigan Department of Corrections.

The Iosco Sheriff's Department is being run very efficiently under the present budget. Operating on the Michigan State Police radio network, this department's patrol cars have instant communications with all police patrol cars in the area, including state, city and township police departments, as well as monitoring radio traffic in the sheriff's office. This system is adequate for our radio needs at the present time. If the department had its own independent radio network, it would necessitate an increased budget for radio operators, plus cost of installing a base station and antennas.
