First Hunting Fatality Here in Six Years

A 26-year-old Owosso city policeman died of gunshot wounds suffered Monday afternoon while hunting west of Sand Lake Road and south of State Road in Grant. Township

Dead is Bruce Rodney Bates. 608 Oakwood, father of two children, who was found with two wounds in the back of his head.

Det. Charles Frank of the Michigan State Police Post, East Tawas, reported Tuesday morning that the shooter had not been identified as yet and that investigation was continuing.

Bates was hunting with his 14year-old foster son, George Banagis, and three others, Jerry Bendall, 31, Corunna; James Whalen, 31, a fellow Owosso policeman and William Whalen, 19, also of Owósso

The five had come to Iosco County early Sunday morning and stayed at a cabin west of Sand Lake Road.

While walking through the brush around 3:15 p.m., Bendall found Bates lying on the ground against a stump. The victim was still breathing at the time. Bendall was unable to carry the Owosso policeman and two hunters who came along, Edward White, 16, Clarkston, and Terry Broome, 18, Oxford, went for assistance.

Bates succumbed to his injuries before help arrived. Exact location of the shooting was eighttenths of a mile west of Sand Lake Road and three-tenths of a mile south of State Road in the vicinity of Pioneer Cemetery.

The body was taken to Saginaw where an autopsy was to be performed. It was thought here that the two wounds in Bates' head may have been caused by 00 buck-
