Supervisor John Hosbach stated that he did not believe the county should become involved in a lawsuit over condemning property and Supervisor Clement Stephan said that many people owning property along Tawas River had expressed concern as to the effect a dam would have on the river.

"Without a resolution," said Prosecuting Attorney William Mc-Cready, "we would not be able to take this matter to circuit court."

Drain Commissioner E. H. Stickney said that an attempt was being made to interest all parties involved in asking for a lower water level. He said that if property owners in the special assessment district realized that they would be liable to pay damages caused
