# **Reed** Arraigned on **Open Murder Charge**

Alvin (Jack) Reed, 47; demand- Alabaster justice of the peace, exed examination Thursday morning amination was set for January 7, when arraigned in justice court 1:00 p.m., before District Judge J. Richard Ernst. on an open charge of murder.

Warrants had been issued the Heard before J. Harry Rapson,

previous week charging Reed with attempted murder. Upon the death of Mrs. Norma Williamson at Saginaw St. Mary's Hospital, Herbert Hertzler, acting prosecuting attorney, authorized a warrant for an open charge of murder. The degree of murder charge would be determined at some later date.

Reed was returned to Iosco County December 21 from Bay City General Hospital, where he had undergone treatment for what is believed to be a self-inflicted throat laceration.

He is charged with fatally wounding Mrs. Williamson during a shooting spree at Whittemore on December 17, along with wounding the deceased woman's aunt, Mrs. Margaret Bronson, 51, and Mrs. Bronson's son, Earl, 22.

Reed, formerly of Whittemore, returned to the area from Union, Oregon, two days before the shooting incident. The shooting spree was said to have been ignited when his estranged wife, Mrs. Leona Bronson Reed, refused to return to Oregon with him.






### Two Hurt on **Snowmobiles**

Parcels involved in the appeal are river front lots, which the power company maintains cannot be sold until expiration of a federal use contract in 1993. Real estate at Cooke and Loud Dams is not federally licensed at present, but it is expected that this will be

the case is unique in that the power company owns most, if not all the river frontage for many miles. As a result, there were no previous sales upon which to base appraisals for tax purposes. When Gem Surveys made its complete reappraisal of real estate in the county, a formula was developed using an appraisal if such land was available for sale. River frontage was appraised at an average value of \$25.71 per foot. The power company appealed appraisals on 30 parcels to the township board of review in March 1968, and the board reduced the river front appraisals to \$20.57 per foot on those parcels, or a 20 percent cut. In addition, wooded land was appraised at \$100 an acre and

submerged land at \$100 an acre. Oates said Friday that the tax commission representatives took the appeal under advisement and hinted that a decision might be forthcoming in a matter of two or three weeks. That period is now lapsed and it is past time for mailing of tax statements to other property owners in the township. Consumers Power Company is losco's largest taxpayer, owning 13,500 acres in Oscoda and Plainfield, which does not include real estate owned by the company in this county.
