Time Limit for Legal Notices Are Submitting IMPORTANT TO YOU! Bills to SS Be Sure to Check These Columns Every Week.

Question: I just found some doctor bills from last year and was wondering if I could still send them in to medicare for payment. Can you tell me if there is a time limit on claiming medical expenses from 1971?

Answer: Yes, there is a time limit. It is December 31, 1972, for services received from October 1, 1970, through September 30, 1971. It is December 31, 1973, for services received from October 1, 1971, through September 30, 1972.

Question: When I went to the hospital earlier this year, I had to pay \$68. They told me this was my deductible. I thought I met my deductible earlier when I had some doctor bills. Now I am really confused. Can you tell me why I had to pay the deductible twice?

Answer: You did not pay the same deductible twice. 
