

Robert E. Jones, operator of the Iosco Hotel in Tawas City, told investigating sheriff's department officers that the three men pounded on the back door of the hotel at 5:15 o'clock, stating that they were police officers and to open the door.

Jones said he thought it strange that police officers would come to the back door at that time of the morning. He loaded a .32 caliber automatic pistol and slipped it in his back pocket.

When he opened the door, Jones was confronted by a revolver thrust into his face by one man. No words were spoken, but Jones struck the gunman immediately, spinning him Ground. The sudden action by Jones apparently startled the trio as all three ran off.

Jones told officers that he fired three shots into the air and ordered them to stop. However, they split up and ran in different directions.

Investigating sheriff's department officers said the three men all wore air force parkas. Investigation continues.
