


Supt. Edward J. Barry emphasized that administration of the base community education program would be turned back to Oscoda Area School when it again

Barry felt that schools of the county have a responsibility for providing such a service to the military.

Walter Owsley, education officer at Wurtsmith, said that the program was designed to help low achievers receive some measure of success in the military. He said that a new directive from the Stra-

tegic Air Command requires that all noncommissioned officers from the rank of sergeant and above have a high school diploma and that a GED test diploma is no longer recognized. Without a diploma, a man would be released from service. The program also provides a refresher course to military personnel who wish to attend schools of higher learning.



State's New **Building Code** Enforcement **Under Study** 

Action on adoption of a new agency to enforce provisions of a state building code is to be taken at the October meeting of the Iosco County Board of Commissioners. Ronald Tyler, prosecuting attorney, told the commission at its regular meeting Wednesday that townships and municipalities of the county had until November 6 to adopt a comprehensive building code or, by law, the county would have responsibility for enforcing the state code. Because of the complexity of the
